



### St. Louis Hoo-Hoo Active

St. Louis, Mo., Feb. 10.—Hoo-Hoo of St. Louis got together today for the first time in months. More than fifty members of the order met at a luncheon at the American Annex Hotel, and these things were accomplished:

W. G. Funck, of the F. J. Shields & Co., was elected Vicegerent Snark for the eastern district of Missouri.

St. Louis Hoo-Hoo was made alive to the responsibilities of caring for the next annual meeting in September.

Secretary-treasurer H. R. Isherwood was formally introduced to the members of the Order here, and was brought closer to them.

Regular weekly luncheon meetings inaugurated last year under the direction of T. C. Whitmarsh, general manager of the W. T. Ferguson Lumber Co., acting as president of the Lumbermen's Exchange, will be resumed.

The meeting was called to order by Laurent M. Tully, formerly Scrivenor of the Supreme Nine, and he introduced Mr. Isherwood. 
