## MEMO



...from  
*the Snark's desk*

This is a very short Snark's report.

In this issue of LOG & TALLY (page 3) are some suggested guidelines and job descriptions for club officers. I am in hope that this will be of some help to future club officers.

In reviewing our project of telling the forest industry story, I find that we are doing quite well. I believe that out of 45 films purchased, 42 are now in use around the world including Canada, Australia and the United States.

Thank you all for doing a good job.

I recently appointed Mr. A. L. Kerper, L-44255, as Chairman of the Hoo-Hoo Redwood Grove Committee. This committee is to include 4 other members beside himself.

I further instructed him to include at least one member of the Supreme Nine at all times, and the other three members to be at his own discretion.

All members of the committee must be members of Hoo-Hoo International who are diligent and dedicated to the good of the Order and the Redwood Grove.

## Suggested Guidelines And Job Descriptions For Club Officers

**PRESIDENT**—The president shall preside at all meetings of the directors and members, and shall have general charge of/and control over the affairs of the club subject only to the board of directors.

He shall be concerned about the over all operations of the club as stated below:

- 1.) Keep in close communication with the International office for the betterment of the club.
- 2.) He shall designate all committees, fix their duties, and amend and alter their responsibilities.
- 3.) He shall designate and appoint chairmen to the major club committees.
- 4.) He will make himself available for counsel for all committees, chairmen, board members, officers, advisors, and to the general club membership.
- 5.) It will be the first obligation of the president to involve in working committees as many members as possible, in order to make the members a vital and important part of the club.

**FIRST VICE PRESIDENT** - Shall act as president in the president's absence, and shall perform other duties as may be assigned to him by the president. He will also be responsible for the following:

- 1.) Responsible for all club programs and social functions.
- 2.) Responsible for obtaining funds for door prizes and other programs outside of the Hoo-Hoo Club budget.
- 3.) Responsible for obtaining locations for programs.
- 4.) Responsible for all entertainment at club meetings such as speakers, bands for dances, etc.
- 5.) Responsible for all seating arrangements at the club programs such as head tables, etc.
- 6.) Responsible for food arrangements at all meetings.
- 7.) Responsible for communicating all programs to the membership such as location, type of program, time and date, etc.
- 8.) Responsible for all chairmanships assigned to him by the president.
- 9.) Responsible for coordination of golf events, and other special events that fall under club programming.
- 10.) Responsible for all other duties assigned to him by the president.

**SECOND VICE PRESIDENT** - Shall act as president in the absence of both the president and first vice president. (As sergeant at arms he shall attend all functions and maintain order.) He will also be responsible for the following obligations:

- 1.) Welfare of the club membership.

2.) Responsible for the phone committee and other important communications to the membership.

3.) Responsible for maintaining a complete and up-to-date membership roster.

4.) Maintain a complete and up-to-date identification label with correctly spelled names and Hoo-Hoo numbers for use at all meetings.

5.) Responsible for setting up all club concats and the selection of degree teams.

6.) Responsible for setting up orientation meetings for new members (kittens) coming into the club in order to make them aware of the fine organization they have joined and to help them feel at home in the club.

7.) Responsible for getting new members to attend our membership meetings.

8.) Responsible for all other duties assigned by the club president.

**SECRETARY-TREASURER** - Although some clubs have both a secretary and a treasurer, these duties are lumped into one office. Each club may decide which officer has what duties. The Secretary-Treasurer shall keep the records of the club, account for all monies received and disbursed, and report to the board concerning the financial affairs. He shall be responsible for:

- 1.) Taking minutes for all board and special meetings, and making sure all officers and board members receive a typed copy of those minutes by the first of the following month after each meeting. He will also place a copy of these minutes in a centrally located place where the membership can read such.
- 2.) Read all minutes of meetings when requested.
- 3.) Responsible for giving financial report at board meetings or at membership meetings where deemed necessary.
- 4.) Responsible for working up an annual operating budget for the coming Hoo-Hoo year.
- 5.) Responsible for making sure that the club membership has an awareness of the club's financial condition at all times.
- 6.) Responsible for notifying the International office of the new club officers elected for the new Hoo-Hoo year prior to convention dates (in September) of each year.
- 7.) Responsible for the collection of both local and International dues and forwarding the International dues to the International office shortly after receipt.
- 8.) Responsible for sending club news with black and white pictures to the International office for publication in LOG & TALLY.

## THE DAVE DAVIS STORY

Hoo-Hoo No. 37575  
Rameses 48

### A Living Past Snark.....

Dave Davis was initiated in Hoo-Hoo in San Francisco in 1925. Together with Lew Godard and Norm Cords, both past Presidents of Oakland Hoo Hoo Club #39, he helped reorganize the San Francisco Hoo-Hoo #9 in 1945 and served as its first President. He was appointed Vicegerent Snark for 1945-46 and State Deputy Snark for Northern California for 1947-48 by Snark of the Universe LeRoy Stanton, 31930, Rameses 41.

In 1949 he was elected to the Supreme Nine as Jabberwock serving with Snark of the Universe Martin Wiegand, 44882, Rameses 42 as well as the following year of 1950-51 to Custocatian serving with Lynn Boyd, 36660, Rameses 43. At several of the national conventions he served at one time as Chairman of all the different committees.

At the 64th Annual Hoo Hoo Convention in Detroit, Michigan, September 16, 1955 Dave Davis was elected Snark of the Universe, succeeding John Dolcater, 37372, Rameses 47.

Serving on the Supreme Nine with Dave were - John J. Santoro, 52280, Newark, N.J., Supreme Hoo Hoo; Cliff R. Ashton, 53424, Detroit, Mich., Junior Hoo Hoo; Ernie L. Wales, 45412, Spokane, Wash., Custocatian; John T. Silk, 53667, Memphis, Tenn., Jabberwock; Donald Barclay, 37595, Toronto, Ontario, Canada, Arcanoper; Robert E. Gallagher, 52499,

Albuquerque, N.M., Gurdon; Harry A. Stockman, 35961, St. Louis, Mo., Bojum; Herbert F. Gustafson, L-29536, Omaha, Neb., Scrivnoter; Herbert H. Baxter, 60440, Charlotte, N.C., Senior Hoo Hoo.

During his term as Snark of the Universe, 1955-56, Dave Davis visited all Jurisdictions, some several times, with a member of the Supreme Nine and Ben Springer, 34265, Rameses 37, Secretary. At this time there were over 13,000 active members in Hoo Hoo with over 100 active clubs. It took over 50,000 miles of traveling, without any expense to Hoo Hoo, (thanks to Simpson Timber Co.) to address over 5000 members of Hoo Hoo with the "History and Workings of Hoo Hoo" as well as many State Retail Lumber Conventions and the National American Wholesale Lumber Association Convention in Vancouver, Canada.

Many new clubs were started at this time and some old ones re-activated. This was climaxed with the Annual Convention at the Fairmont Hotel, San Francisco where "The City That Knows How" held the most successful and one of largest attended Hoo Hoo meetings. At this convention Cliff Schorling, 45533, now Rameses 49 was elected Snark.

When residing in Eureka, California, 1960-68, Dave was instrumental in helping to get Humboldt



Hoo Hoo Club #63 to be one of the most active clubs in California. During each one of these years all the Snarks of the Universe, as well as several Rameses, visited this club for "Hoo Hoo Celebrity Night", at which time a Concat was held and a feed of Eureka cracked crab with all the trimmings was enjoyed.

In 1923, Dave Davis started in the lumber business in San Francisco and served the last several years as Sales Manager for some of the large redwood manufacturers.

Retiring in 1970, he is now residing at The Tamalpais, a high-rise retirement residence, in Greenbrae, California, a suburb of San Rafael, twelve miles north of San Francisco, across the Golden Gate bridge. Dave's wife Dottie, who contacted polio on one of the Snark's trips to Boston, is still confined to a wheel chair, but is enjoying bridge and traveling.

Dave has been playing a lot of golf with a ten-handicap, but on October 17, 1972 underwent major surgery which brought golf and traveling to a halt, however, is now back in action at the age of 68.

Dave wants all of his old friends that he had an opportunity to work with during his many active years in Hoo Hoo to know that he lives with the cherished memories of the many pleasant times we had together.

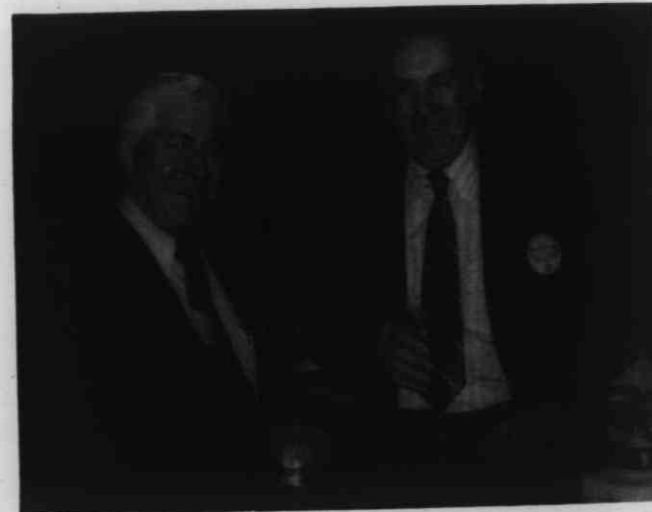

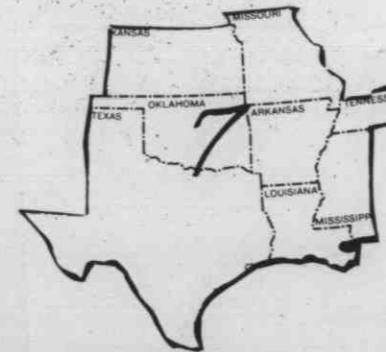

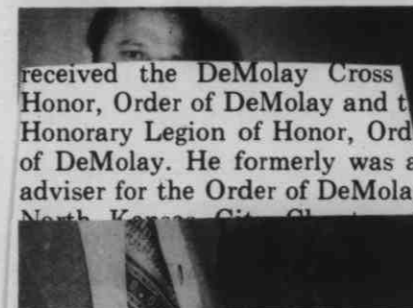

## OBITUARIES



Laurence J. Owen 47665, Rameses 63, died suddenly at his home December 1, 1972.

Larry, as he was known by one and all, was a member of the Supreme Nine from 1966 to 1969, and was elected International Vice President in 1969. He became International President in 1970, and International Chairman in 1971.

Perhaps Larry was best known for his efforts in raising enough money to establish the Hoo-Hoo Redwood Memorial Grove.

What Larry liked to do was get up near the close of a Hoo-Hoo meeting and tell his story. He told what it (the Redwood Grove) was and what Hoo-Hoo was trying to do. Inevitably the money came flowing in.

Like one night at a Hoo-Hoo meeting in Miami. It was a moving experience for Larry, for while he was talking, lumbermen began to dig into their pockets, coming up with a dollar here and a dollar there, passing it to the front of the room. Or in Oakland. The Board of Directors of Club 39 contributed money from the treasury. Then each man present dug into his pocket and donated money. And so it went.

Finally the fund went over the top. Hoo-Hoo had raised \$5,600, and Larry had raised the greatest portion. The State of California matched the \$5,600 and Hoo-Hoo had a Redwood Grove. It was dedi-

cated September 13, 1969, and is located about 40 miles north of Eureka, California.

What about Larry? A modest, quiet, unassuming man, he would probably sum it up best in another way.

While talking to a visitor, the phone rings. Excusing himself for a moment, he picks up the phone and talks to a customer. After finishing, he turns back to his visitor and says, "You know, when somebody calls me on this phone I always try to pick it up right away. I don't like my caller to be asked, 'Who's calling?' Heck, I'm just Larry Owen."

There were 66 members present in spite of the bad weather.

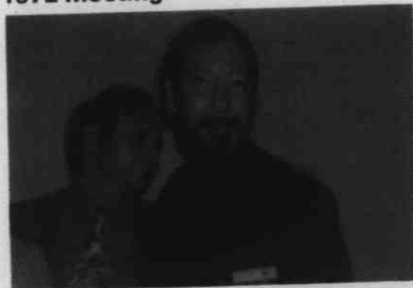
Pictures of Charter Night and subsequent events were passed around for some reminiscing and general comment.
