The membership committee of every club should be concerned about getting new members, but also finding ways of keeping the new members interested in staying in the order.

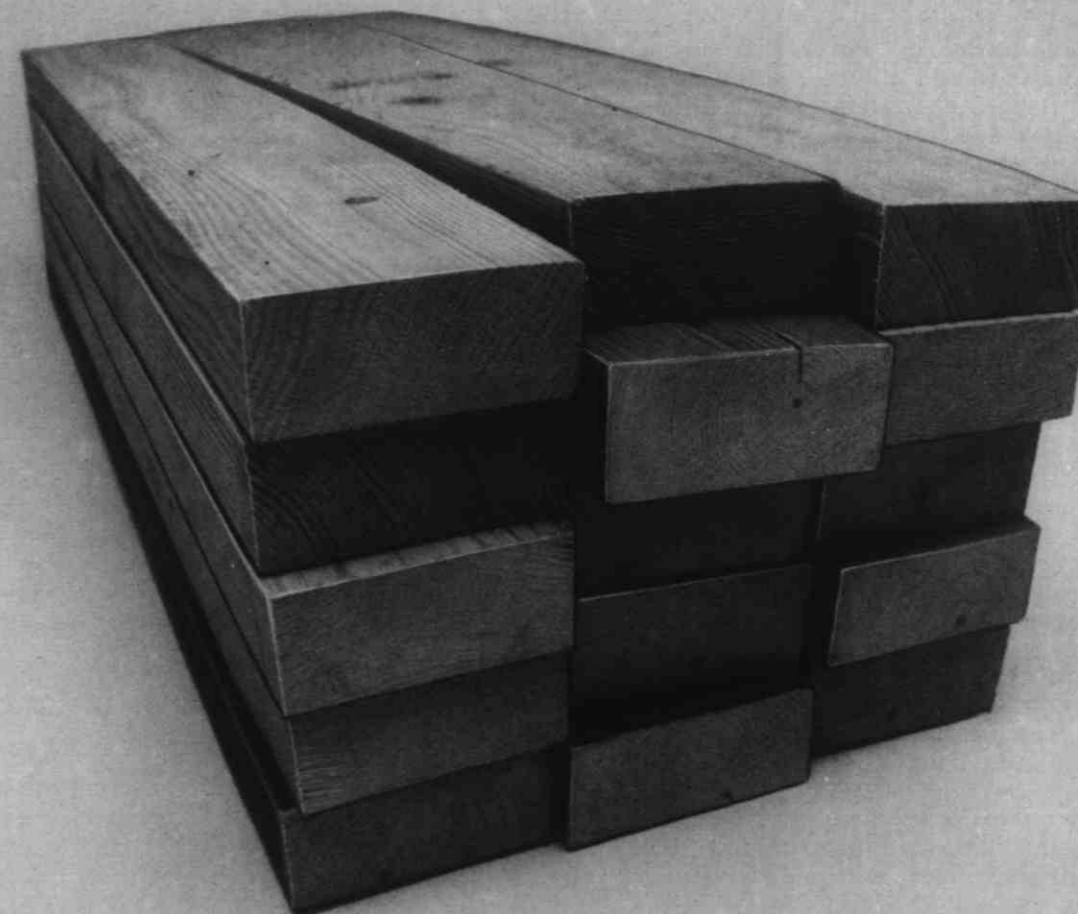
During the next few months many Jurisdictions will be having their Jurisdictional Conferences. These workshops are beneficial to good club operations and add to the regional cohesiveness of the clubs involved. This year more emphasis should be placed on growth in Hoo-Hoo, as we can increase our membership with a little more effort by all members. We need to gain the confidence and cooperation of top management in our industry giants, which will lead to greater participation by many of our large forest products corporations. Hoo-Hoo can be the agency for the grass roots support in many of its problems in the environmental areas that is causing so much trouble from a production stand point and in capital needs of the industry.

Clubs looking for programs to participate in on a local level, and have not looked into participating, there are programs on a national scale that are state operated in all 50 states now. Are you participating in the following national activities?

AUSTRALIAN REPORT

Your Snark was privileged to travel to Australia in October for Jurisdiction Four's annual Conference that was held in Adelaide this year. The first Hoo-Hoo club in Australia was started in Adelaide just 13 years ago and in this short span of time 5 other clubs have been started and are functioning in Australia's principle cities. These clubs are located in Brisbane, Sydney, Canberra, Melbourne, Mount Gambier and Adelaide. There is a strong possibility of a new club starting in Tasmania which is the island off the south coast of Australia. For the future, New Zealand has potential clubs to be activated in the forest products industry but a name conflict must be resolved in the mean time.

Hoo-Hoo in Australia has provided a vehicle that has been able to bring all segments of the industry together for the first time as no association or industry agency was providing this function. For the past few years Jurisdiction Four has been holding Conferences in the middle of October at one of the Cities which club is the host. This is the first time that the International President has attended their Conferences and I hope not the last, as these people were most hospitable and gracious.

Their Conference Starts on a Friday nite with a cocktail hour and buffet dinner. Saturday meetings are given over to Jurisdiction reports and club activities and operations. Saturday nite was a social evening with a dinner and music hall type of entertainment. Sunday was an open day with a visit to the wine producing area and a barbeque on the winery grounds.

Monday was given over to industry problems with experts in their respective field giving reports on problems facing the timber industry and projections for the future. Monday Evening was the final event of the Conference, with a banquet and the awarding of recognition trophies to members who had contributed so much to the organization during the

Forest History and the Lumber Business

At first glance, "business" and "history" might seem to have little in common. History, as they say, "bakes no bread." It can't tell the lumberman how to increase his sales, or how to improve the efficiency of his operation. "American history should be taught in every school," the modern businessman would say. "But it doesn't have anything to do with the operation of my lumber business."

On the contrary, American history is vitally important to the lumber business and every phase of operations of the forest products industry.

An unfavorable climate of public opinion, generated by well-publicized criticism of the industry but fostered by wide-spread public ignorance and misinformation, has lead to conditions that have

the cooperation of top management people which makes it easier to recruit the other people of these businesses. All clubs are involved in local industry problems or are supporting some worthy charitable organization. The Australians are looking forward to the day when they can host an International Convention and some day see one of their members as Snark of the Universe.

In 1977 Jurisdiction Four will be celebrating its 15th year of existence and the Jurisdiction Conference will be held in Canberra that year, the Capital of Australia. adversely affected forest utilization, production, prices, and some market variables. As informed public wouldn't have let it happen, according to some experts.

Informational resources that might have led to a higher level of public education about our forest resources include American history textbooks. American historians have neglected the story of forest utilization and the role wood products have played in building this nation. This neglect, along with other factors, helps to explain why the public, the media, and many of our elected officials have not taken a more positive view of industrial forest management and the forest product industries.

As George C. Cheek, executive vice president of AFI, pointed out in the August 1975 *Log & Tally*, "People believed we were running out of timber and forest...that industry owned most of the forest...(and) that nearly all the forest was in the west." Without factual background, without some familiarity with the historical progress of the industry, people were vulnerable to propaganda and half-truths, and the forest products industry was vulnerable to the political fallout which followed.

The Forest History Society, a nonprofit educational institution based in Santa Cruz, California, believes it is time to let the American public know that our forest history is a proud part of the American heritage. For nearly three decades the Society's program of collecting, researching, and publishing the story of man's use of North American forests has aimed at educating the public. The Society's work, as it contributes to public understanding, benefits everyone in the forest-related community.

The Society publishes the quarterly *Journal of Forest History*, a lively and interesting magazine laced with authentic historical articles and photographs. To

stimulate quality writing on the subject of forest history, the Society offers cash prizes to authors of the best articles published each year in its own *Journal* and in other magazines. In the past year it has published three forest history books and a catalogue, and three members of its staff have been putting the finishing touches on history books that will be published this year. The Society's magazine and books help raise the level of public education on the subject of our forest history.

Recent events in forest history are preserved by making tape recorded oral history interviews with older members of the forest community. With funding assistance from sponsors, interviews are published in hardbound volumes for purchase by libraries and interested individuals. Recently published oral histories include a four-volume series on the red cedar shingle industry, an interview with retired Forest Service Chief Richard E. McArdle, and an interview with George L. Drake, retired vice president and chief forester for the Simpson Logging Company. Most interviews are made by the Society's executive director, Elwood R. Maunder, one of the foremost oral historians in the country.

The Forest History Society is funded entirely by donations, grants, and membership dues. Members provide a vital function, not only lending financial support to the Society's history program, but by sharing ideas, suggesting projects, sending in news items, and gathering new members into the fold. Members write in about collections of old logging photos, business records, and old logging tools and artifacts. The Society helps to locate institutions that will put such things to educational use.

Another FHS Publication

Publication of "A Forester's Log: Fifty Years in the Pacific Northwest," an oral history interview with George L. Drake, has been announced by the Forest History Society, headquartered in Santa Cruz, California. Drake retired as vice president of the Simpson Logging Company, Seattle, Washington in 1954. The volume includes a short interview with the late Charles S. Cowan, onetime executive secretary of the Washington Forest

Fire Association. The interviews were conducted by Elwood R. Maunder, executive director and oral historian with the Forest History Society.

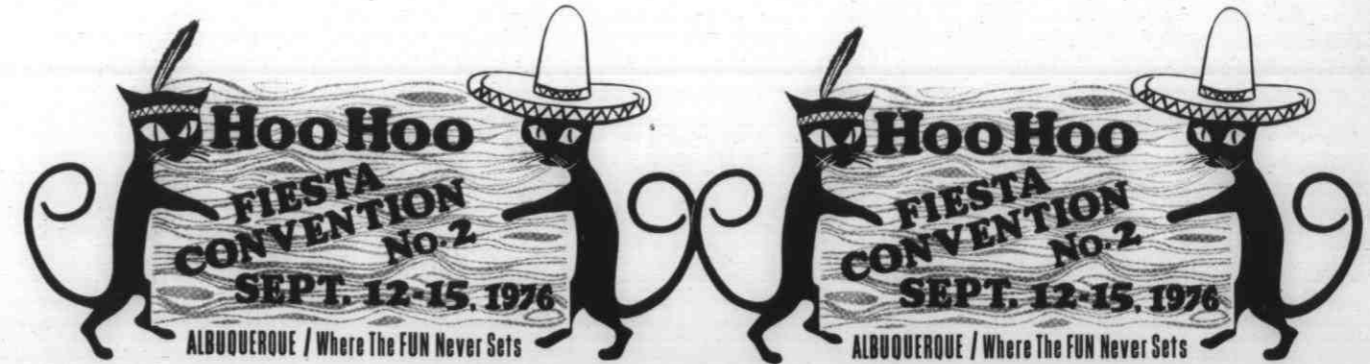
George Drake began his forestry career in 1912 with the U.S. Forest Service, cruising timber near Klamath Lake in southern Oregon. In 1914 he was transferred to Alaska, where he served a four-year stint before returning to a new Forest Service assignment in Oregon.

In 1930 Drake joined the Simpson Logging Company, working as assistant to its president, Mark E. Reed. Drake's work in-

involved him in labor relations, land acquisition, sustained-yield management, community relations, safety programs, and the Pacific Logging Congress. In his interview he discusses friends and associates such as William B. Greeley, onetime chief, U.S. Forest Service; David T. Mason, the "father" of sustained-yield management; trade journal publisher George Cornwall; and Mark Reed, C.H. Kreienbaum, and William G. Reed of Simpson Logging Company.

Hoo-Hoo Fiesta Convention #2 In Stride With Bi-Centennial

As this bi-centennial year gets under way Americans are taking special interest in the people, places and events that have contributed to the formation and character of our great nation. With this in mind Convention guests will again have the opportunity to visit an Indian pueblo during their stay with us in September. Visitors to New Mexico in any year are aware of the unique character of the great Southwest with its overlapping Indian and Spanish-American cultures. The customs and traditions of these great cultures are centuries old yet remain remarkably intact and have gradually fused to each other under the steady pressures of modern civilization and the inevitability of change.

Pueblo Indians differ greatly from the nomadic tribes. They are in a sense part of a great family of pueblo dwellers yet each pueblo retains its own individuality. The people belong to one major linguistic family but there are subdivisions of the language dividing them. Religious customs vary but all worship nature in all its manifestations and do so with colorful and dignified ceremonials. Each pueblo remains a distinct and individual unit and only once in their long history have they joined



Navajo Indians doing some rug-weaving.

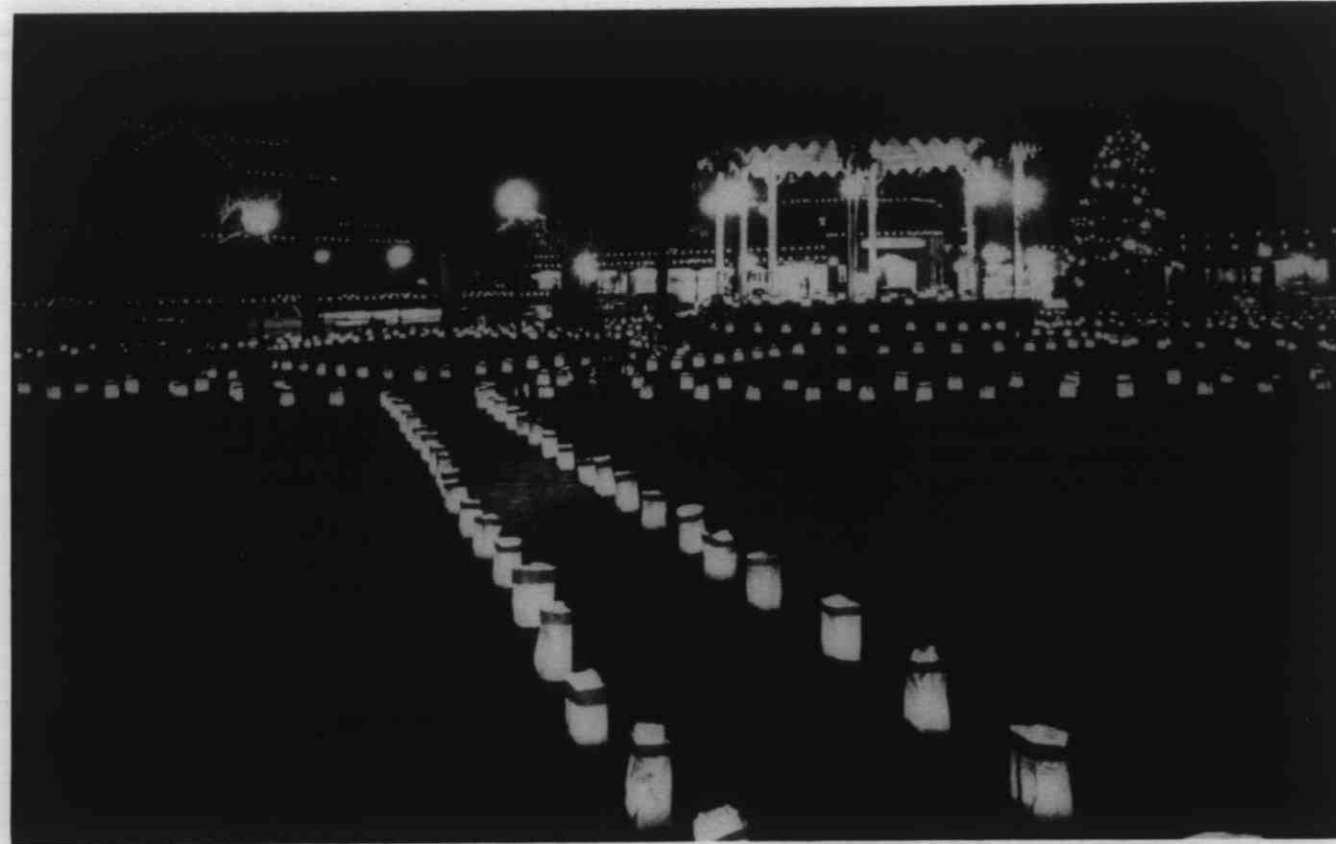
together in a united effort. This took place during the great Indian revolt of 1680 when the pueblos joined in a unified effort to drive the Spanish from their land. The Spanish Conquistadors first penetrated into the lands of the pueblo Indians dwelling near the Rio Grande Valley when Elizabeth I was Queen of England.

The pueblo Indians are noted for their creative and artistic talents. Perhaps the stability of pueblo life lent itself to artistic expression as pottery and baskets, ordinary housekeeping utensils,

are decorated with colorful design and the technique and workmanship are of superior quality. Pueblo Indians are best known nationally for their silver and turquoise jewelry beautifully crafted in handsome designs for both men and women.

*Mercado Plaza Provides
Intimate Shopping Area*



A unique collection of arts, crafts, boutiques and restaurants await the visitor at the new 62,000 square foot Mercado Plaza extending through a "paseo" or passageway from the lobby of the Sheraton Old Town Inn.

This, the first phase of the Mercado or "market place," stretches southward for a block toward Historic Old Town, the arts-and-crafts center of this picturesque city, founded in 1706. Construction of the second phase of the Mercado starts this spring, and will nearly double its size.

Of the stores and facilities encompassing the Mercado, most are as different as the area: five galleries; four shops featuring Indian jewelry; a fine seafood restaurant in the arid southwest; a Japanese steak house; and the first retail store operated by the world-famous Chimayo weavers.

"The design of the Mercado—intimate, cozy, unified by a landscaped mall with high ceilings supported by the traditional Mexican 'viga,' or crosslog—lends itself to attract strolling musicians and create a bazaar or fiesta

atmosphere throughout," says architect John Varsa of Wendell, Varsa and Associates.

The names of the shops, even, convey the mystique of this historic region: Zuni East, the Stitching Horse, Lol-La-Pa-Loo-Za, Palacio Mexican, Ya-Ta-Hey, Gifts Unusual, and Something Unique.

For those who recall Coronado was searching for the Golden Cities of Cibola when he trekked through the area in 1540, the mood of the Mercado is conveyed by shops such as the Golden Bough, for jewelry; the Golden Unicorn, featuring candy and gourmet food imports; and the Golden Mermaid, an oasis of superb seafood.

For clarification, the Indian arts and crafts centers are Ya-Ta-Hey, Zuni East, Something Unique and Ortega's, the famous weavers from Chimayo. The Galleries, well-known throughout the area, include Brandywine, Colbert, Gallery One, Dale's studio and gallery, and Jacob's gallery and frame shop.

Stores featuring high fashion apparel currently are Ann's, Nat-

urally, and Liz's, both representing exclusive lines in quality women's clothes. High fashion adornment and gifts include the previously-mentioned Golden Bough; Eden's fine jewels and gifts; and Gifts Unusual West by Maisel's, sterling silver and custom made jewelry and other rare imports.

Rounding out the specialty boutique and service operations are the Stitching Horse, which produces and sells quality leather goods; the Golden Unicorn, with its unusual candies; and Lol-La-Pa-Loo-Za, a full-service hair design house.

Three restaurants are the Samuri Steak House, the Golden Mermaid, and a nightclub-supperclub to be operated by the Hotel.

"The Mercado, we hope, is an extension of Old Town, the natural terminus of which is the hotel," says Albert A. Anella, leasing agent for the Plaza. "We have attempted to provide an architectural transition in keeping with the Southwestern-and-adobe mood of the area."

Club #39's September meeting was the installation of the 1975-76 officers and directors.

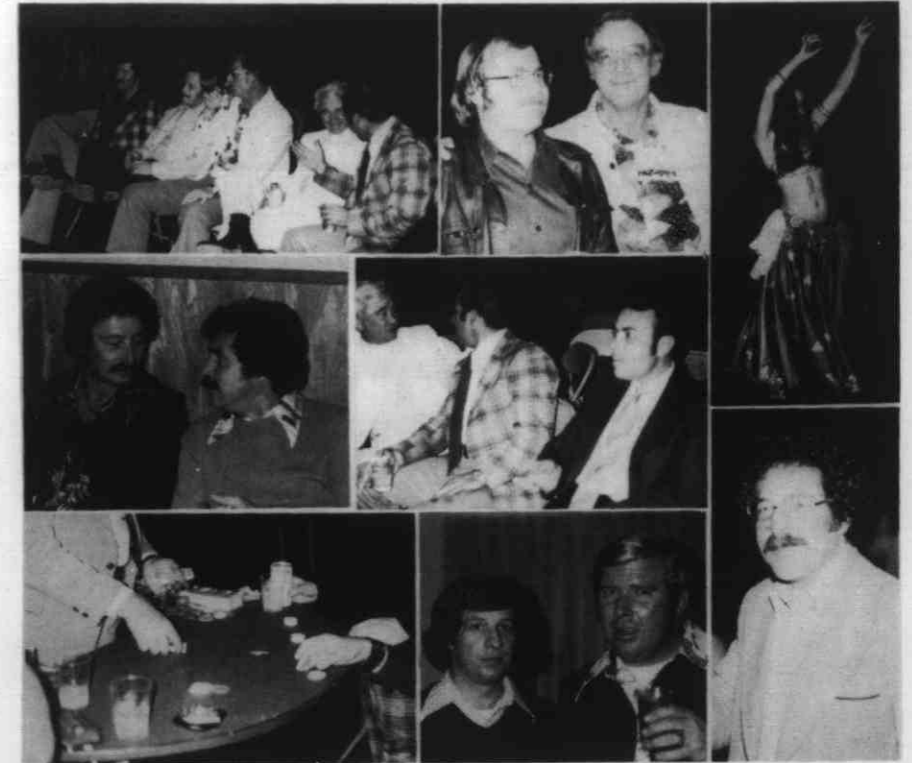

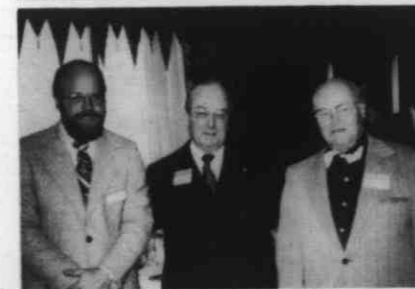
Gaming tables included a selection of poker, hearts, blackjack, craps, chuk-a-luck and roulette.

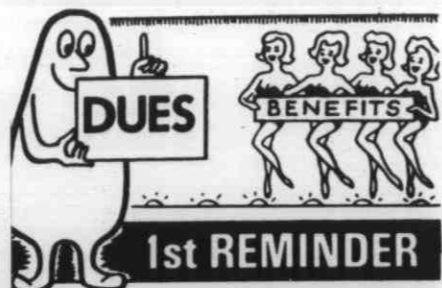

With 85 attending, a color TV set was given away as a door prize along with several other smaller appliances. **Jim Walby** won the TV set.

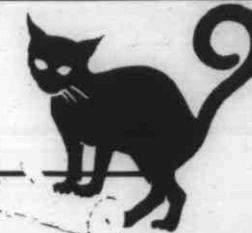

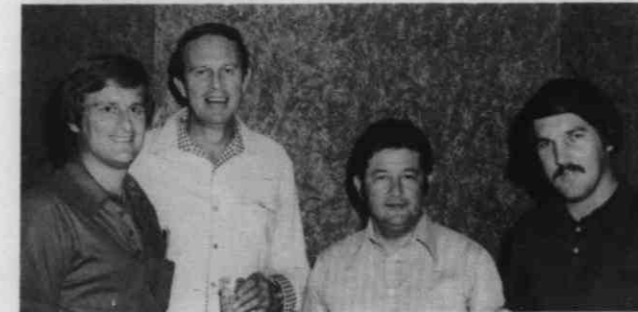

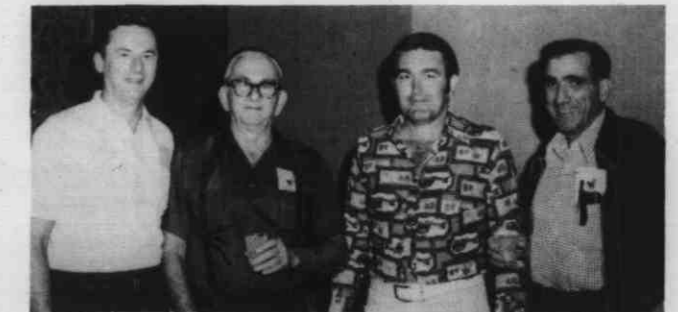
