

**Learning Tree Receive
Recognition**

The Conservation Education Association (CEA) has awarded its Distinguished Service to Conservation Environmental Education Award to the American Forest Institute (AFI), the forest products industry's information and education organization, for its initiation, development and implementation of Project Learning Tree (PLT).

PLT is an environmental education program for use with youth in kindergarten through grade twelve and is co-sponsored nationally by AFI.

The award is presented "to acknowledge and recognize outstanding accomplishment achievement of national significance in conservation environmental education." AFI will be the first organization to receive the award.

The award has been given only three times in the past: to Senator Gaylord Nelson, Congressman John Brademas and Dr. Paul Brandwein.

In his reply to CEA's Awards Chairman, Alan Sexton, AFI's Chairman Brenton Halsey said, "Since its founding nearly ten years ago, PLT has grown out of a partnership between industry, resource managers and educators. That partnership is what makes PLT a success. Without the thousands of volunteers in the field — many of them educators who give freely of their time to train others — PLT would still be an idea, or worse, just another curriculum collecting dust on a library shelf. In many ways, this Award 'belongs' to them."

The Conservation Education Association, founded in 1953, is open

to all persons and organizations interested in forwarding the broad aspects of environmental and conservation education.

PLT also played a prominent role in the recent recognition of the Western Regional Environmental Education Council (WREEC), the program's national co-sponsor. WREEC received the Distinguished Service Award, given annually to an organization from the North American Association for Environmental Education during its fall annual meeting.

According to Dr. John Disinger, Ohio State University, who nominated WREEC, one of the reasons for the recognition was the "development of materials that work, Project Learning Tree and Project WILD."

FINANCIAL REPORT

Mr. Barber presented the museum financial report to the Board, saying the total assets had increased since the last month's statement. He reminded the members that all donations to the museum are now tax deductible, referring to a notice to that effect in November 1984 LOG & TALLY. A contribution of \$1,000 (Australian funds) from Melbourne Club 217 via Graeme Smith Timbers Pty. Ltd. to go toward the building fund was noted and appreciated.

Upon motion by Mr. Meier, seconded by Mr. Breeden, the Board approved the financial statement as presented.

W.O.P.S. & FUND RAISERS — McCARTHY STYLE

Mr. Jones gave a report on a new program devised by Worrall J. McCarthy L-86521, S-9 representative from Jurisdiction IV, to raise funds for the museum. Under his direction, a new society titled W.O.P.S. (Wooden Outhouse Preservation Society) has been formed with limited memberships available for \$200 apiece. Mr. McCarthy stated in a letter that he hopes to raise about \$20,000 from the sale of memberships, \$16,000 of which would be donated to the museum.

Mr. Jones also said Mr. McCarthy was interested in selling enlarged, framed photos of the museum building for \$100 per with proceeds going to the museum.

NEW ANNEX

Mr. Jones also reported on the progress of the new annex in Gurdon, recommending that Don Stone be given permission to proceed with construction. He also told the Board that a fireproof room should be built inside the annex to house old records and other materials precious to Hoo-Hoo history. He again thanked the individuals and clubs who have made donations to this cause.

Upon motion by Mr. Barber, seconded by Mr. Meier, the Board agreed to proceed with construction by instructing an attorney to obtain a building permit for the annex and extend the lease an additional 30 years.

MUSEUM VISITS

Upon suggestion by Mr. Barber, the Board agreed that the museum director should travel to other forestry museums, namely the Texas Forestry Museum in Lufkin, to obtain display ideas, and should be done at the first available opportunity.

ADJOURNMENT

Having completed its business, the Board adjourned at 3:59 p.m. upon motion by Mr. Barber, seconded by Mr. Meier.


