MEMO ...from the Snark's desk

John G. Hickey, 60300, Rameses #56, was initiated into Hoo-Hoo in 1953 in Toronto, Ontario by a Concat put on by the Buffalo (N.Y.) Hoo-Hoo Club #71. John was the first President of the Toronto Hoo-Hoo Club #53.

One of the early highlights of John's Hoo-Hoo life was attending the Hoo-Hoo Convention in Houston, Texas, accompanied by the genial Don Barclay. It was in Houston that John Egan was followed by John Dolcater as Snark.

The original Toronto Concat included a goodly number of ardent Hoo-Hoos who helped immeasurably to put the local club on the road to success. Many are still active. The Toronto Club has always had an outstanding executive group. The present officers are doing a whale of a job, organizing a mini-convention in Jurisdiction V at Harrison Hot Springs in Beautiful British Columbia May 24th-26th, 1974.

During his term as Snark, John visited 20 states and 6 provinces.

Much was accomplished by the Supreme Nine that year. The efficiency of the Nine, led by Ed Wade's experience, George Meuth's acumen to face facts and Glen Ross's generalship, were of great assistance in the reorganization of the International Office.

John spent many winters as a youth in the woods cutting and sawing (portable mill). In 1935 he joined the Panville Door Company.

During World War II, he was with B.C. Plywoods, Ltd, and the Toronto Door Company.

The day after VE day, he started his own business, Kingsway Lumber, Ltd which was sold to MacMillan, Bloedel Ltd in 1966.

Since then he has been retired. His two sons operate a hardwood plywood and veneer plant (Vicply, Inc). From October to April, John enjoys the Florida weather, playing golf and enjoying life with his wife, Kay, at Arrowhead in Fort Lauderdale.

Wood Promotion Award

Hoo-Hoo International award, right, to be presented at the convention in Detroit in September to the club judged to have made the greatest accomplishments in Wood Promotion in 1974.



Hoo-Hoo Wood Promotion Trophy

The annual award of the Wood Promotion Trophy will be made at the Hoo-Hoo convention each year. The award is made to the Hoo-Hoo Club which, in the opinion of the judges, has made the greatest accomplishment in wood promotion activities during the previous Hoo-Hoo year. The trophy is a large walnut sculpture of the Hoo-Hoo cat. The trophy remains in the possession of the winning club during the Hoo-Hoo year. The club to whom the award is made will be responsible for delivering the trophy at the next convention.

The Snark of the Universe will appoint a special committee as judges for the award. All clubs are invited to participate.

RULES GOVERNING CLUB TROPHY AWARD

1.) The club may submit evidence covering all wood promotion projects adopted by the club, including National Forest Products Week.

2.) The entrant club will make its presentation to the judges and the convention. Tangible evidence of the project (s) must be submitted by the club delegate, who must be conversant with the project from start to finish as he may be interviewed by the judges. This evidence may consist of newspaper clippings, photos, scrap books, samples, or display material. A slide projector will be available.

3.) Each participating club must submit a written outline of the wood promotion project (s) to contain the following: (a) A description of the project (s); (b) State the goal of the project (s); (c) Tell of the method of operation; (d) Specify the relative proportion of financial and/or manpower support from cooperating organizations; and (e) Statement of the results.

4.) Do not send club contest materials to the International Hoo-Hoo office. The Club delegate is responsible for all contest materials, and to provide the LOG & TALLY magazine with a complete story for publication. The delegate may ship the materials, addressed to himself, in care of the convention hotel, marked "Hold for arrival on September 16th."

5.) Decision of the judges will be final. The judges will give full consideration to the relative sizes of competing clubs. Appropriate weight will be given to the longer lasting effects of the projects. A club is eligible to be awarded the trophy in two or more consecutive years. In the absence of an acceptable club presentation, at the discretion of the judges the trophy may be retained in the International Headquarters for one year. No judge shall be appointed who is a member of a club making a competitive presentation.

6.) Hoo-Hoo Clubs wishing to make a presentation for the trophy are requested to advise the International Office by letter prior to August 20th of each year.

Four turkeys and one goose were offered as door prizes. They were won by Leona Munje, Hank Munje, Bob O'Brien, and Nancy Sissons.

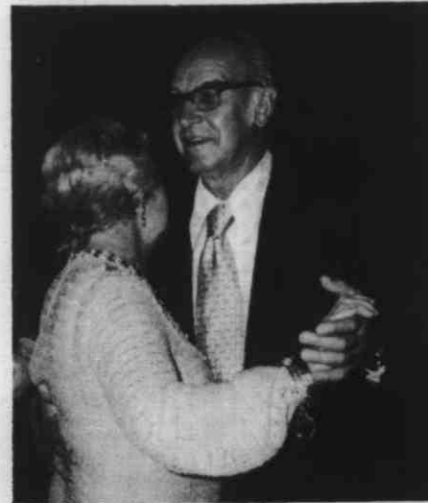

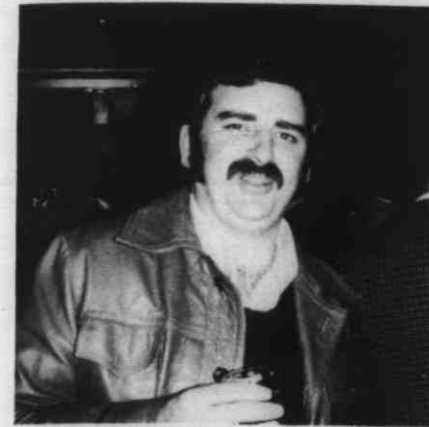

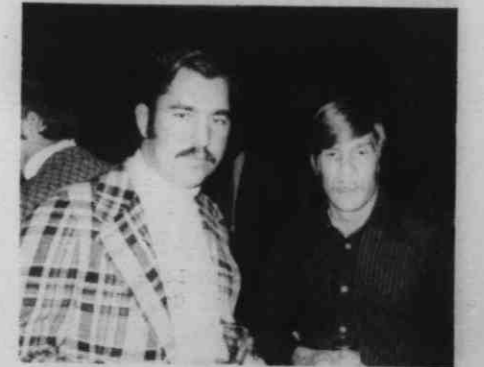

OBITUARIES

Ben F. Springer Dead at Age 86

Benjamin F. Springer 34265, Rameses #37, Seer of the House of Ancients, and probably the best known Hoo-Hoo member in this organization's history, died March 6th of complications of old age. He was 86 years old.

Brother Ben, who until recently lived at the Knickerbocker Hotel in Milwaukee, was executive secretary of this organization from 1931 until he retired in 1963.

He was born in Milwaukee and attended the old East Division High School, now Riverside.

He sold ice cream to youngsters in his neighborhood. It was the custom to sell ice cream on butcher paper, but Springer found a baker producing a cakelike cracker and reportedly became the first in his area to sell ice cream sandwiches.

He worked his way through the University of Wisconsin—Madison by performing with a band. He was graduated in 1910.

Springer began his long career in the lumber industry as a salesman for the old Kieckhefer Box Co. In 1911 he went to work for the John Schroeder Lumber Co., and remained with the firm until 1930.

While with Schroeder he formed the Playskool Institute, manufacturers of educational wood toys that remain popular with children. That business interest later was sold.

Springer joined a lumbermen's organization in 1924. He built Hoo-Hoo, which promotes the lumber industry, into a world wide organization of more than 12,000 members.

He served as president of the organization for three years before becoming its executive secretary.

Alfred L. Jones 31723, we have been advised passed away June 14th, 1973. He had been a member of the Kansas City Club #43 where he became a member in January, 1922. Al was 81 years of age.

Glen W. Ross 45275, Rameses #57, Past President of Hoo-Hoo International and long time conservationist in Minnesota, died in February at the age of 72 of a heart attack.

Mr. Ross joined Hoo-Hoo at Minneapolis, Minnesota in 1938 and had been a continuing member of the Twin Cities Club #12.

Mr. Ross was chairman for Citizens Committee for Natural Resources, which was influential in developing and carrying out conservation measures passed by the Minnesota Legislature.

Mr. Ross, President of the Suburban Lumber Company in St. Louis Park, began his interest in conservation and the lumber industry from pioneering lumberman T.B. Walker.

He was also a past President of the Independent Retail Lumber Dealers Association, and a director of Produce State Bank of Minneapolis Environmental Sciences Foundation and a member of the board of directors of the Voyageurs National Park Association and the Minnesota Izaak Walton League.

He is survived by his wife, Maxine; two sons, a brother and a sister.

Jack H. Kreindler 62048, passed away September 21st, 1973 at the age of 70.

Jack lived in Albuquerque, New Mexico until recently where he joined the Albuquerque Hoo-Hoo Club #69 in May, 1954.

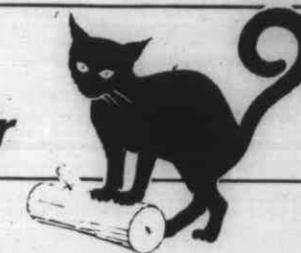

Dear Cliff:

I'm certain that our members would like to be filled in on the details surrounding the passing of our venerated Seer of the House of Ancients, Ben Springer. I, like you, had been advised that Ben had fallen in his suite late in January and that he had been hospitalized and put in intensive care.

Although we were kept informed of his condition by his secretary and members of the Milwaukee Hoo-Hoo Club, I determined to conduct a personal investigation of his condition and treatment.

When I visited Milwaukee on March 4th, I spent the day tracing Ben from the hospital to the Colonial Manor Retirement Home. I went out to the home and although I found that Ben's condition was grave, I was comforted to know that he was in excellent hands, thanks to a very competent and concerned staff. I also was determined that his affairs were being handled adequately by relatives, with whom I spoke in great length and detail concerning his care, finances etc. However, I left Milwaukee with a heavy heart knowing that it was just a matter of time until I would have to return.

The return trip came even sooner than I expected as I received a call Wednesday afternoon that Ben had passed on. The funeral service was held the following Saturday morning, and even in death the fine hand of Ben guided the play. In his own thorough fashion he had arranged everything in advance.

Cliff Cunningham, David Marteny and I represented International. Cliff and I were met at the airport by Frank Haybeck, Secretary of the Milwaukee Club, and driven to the funeral home, and there we were joined by Dave Marteny.

Ben had selected Ave Maria and Largo as preludes. Reverend Lance Herrick of the Kenwood United Methodist Church conducted the service and eulogized Ben for his devotion to family, friends and his beloved Hoo-Hoo. His remarks were taken from the Sermon on the Mount and developed appropriately around the theme of ye are the salt of the earth. Former S-9 Al Groskopf added his personal eulogy recounting many intimate and poignant experiences with Ben and ended his remarks by saying that if all Hoo-Hoos could speak as one they would undoubtedly have one last shout in unison, "Stand up, Ben - we love you!"

An old friend of Bens, Marvin Moran, once solist for the Milwaukee Braves, whose friendship with Ben stemmed from their mutual love of music, sang. Ben had requested the 23rd Psalm, and he ended the service with a touching rendition of The Lord's Prayer.

Ben had left instructions with his secretary to select six honorary pallbearers (it was a memorial service as he was to be cremated) who would be those he would have picked and she selected Al Groskopf, Joe Balthazor, Clyde Haas, Stan Baker, Frank Haybeck and Phil Mork, all close Hoo-Hoo affiliates.

There were a number of floral tributes placed around a magnificent wooden casket. From one floral arrangement there peeked a subdued black styrofoam cat, and below the podium was another outstanding piece from whose base projected a piece of old weathered board, a fitting tribute to a lumberman.

The final resting place of his remains is, appropriately, Forest Home Cemetery of Milwaukee.

At the time of this writing the Toronto Home Show, Canada's largest exposition of this kind is in full swing and, drawing crowds 3 and 4 deep in front of the Hoo-Hoo booth, are two boys carving

supervision of their Industrial Arts teacher. Each project is required to have a wood content of 80% or more.

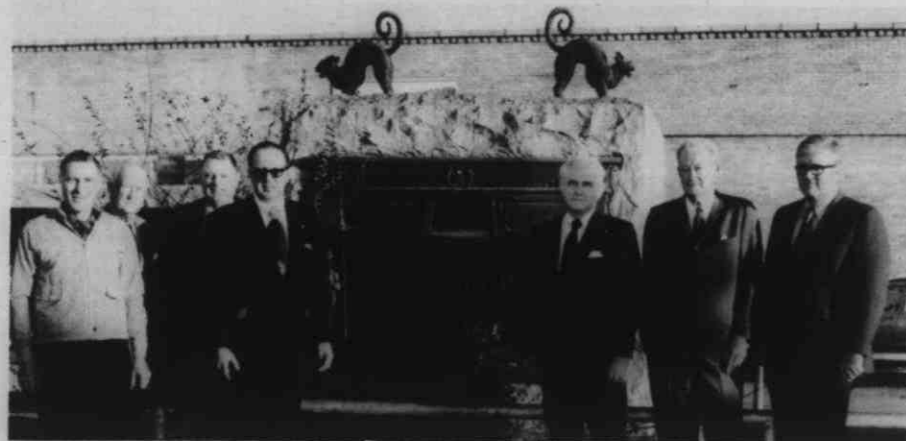

(3) **Turnings** - where the primary skill has been the use of the lathe.

(4) **Laminating** - where the primary skill has been that of laminating.

(5) **Models** - buildings or other mock ups of projects (no kits).

(6) **Sculpture** - free form pieces (NO DRIFTWOOD)

(7) **Open** - for projects so constructed that they may possess considerable amounts of several skills—joinery, lamination, turning, bending, sculpture, design, etc.

A 1st prize scholarship of \$30.00 and a 2nd of \$15.00 is awarded in each of the seven categories.

In addition to these awards, a first prize scholarship of \$75.00, a second of \$50.00 and a third of \$25.00 will be presented to the three projects judged to be the best of the show. All projects in all categories are eligible and consideration is given for the following:

(a) **Design** - Suitability to function - Appearance - Design of construction - Complexity of design.

(b) **Craftmanship** - Joinery - Lamination - Turning - Bending - Free form sculpture - Finish - Quantity of work.

In order that each project be fully appreciated for the skill involved in its construction and design the four judges are carefully selected. This year they were: Les McKimmie representing the club and bringing to the judging his years of industry experience including pioneer work on the Canada Wood Council; Syd Thomson from the staff of a major Toronto architectural millwork firm; R. MacPherson from the Ontario Ministry of Education and Wm. Sloane from the Faculty of Education, University of Toronto.

This year there is an added honor that goes to the student who submitted the project judged to be the best of the show. He will be presented with the Syd Illsley Award. This beautiful carving was commissioned by a grateful Toronto Club #53 in recognition of Syd's friendship and service to our club as secretary and Supreme Nine Member and particularly for his work as a charter mem-

FOREST MANAGEMENT AND WILDERNESS AREAS

Views of An Environmentalist

Executive Secretary of **Outdoors Unlimited, Inc.**, Robert S. Nobis is a different type of environmentalist.

Though a longtime member of the **Sierra Club** and a forthright advocate of the Sawtooth Wilderness Bill and wilderness areas such as Alpine Lakes in Washington, Nobis feels that some of his fellow environmentalists have gone too far when they suggest *no timber management* at all and placement of vast tracts such as the entire Salmon River Breaks Area under wilderness classification. He suggests that both the Salmon River and Idaho Primitive Area be returned to **multiple use**.

Recreational Use

Nobis feels that Idaho has "a tremendous recreational potential" and is in disagreement with anyone who would deny that the state hasn't already been boosted by recreation and couldn't be advanced still further.

To note—he emphasizes "this potential is not totally on wilderness". The four percent who go into the rough, undeveloped areas do need areas set aside but *not the whole forest*. "What we need is development of campsites, scenic roads, overviews, and sanitary facilities" for the majority of outdoor enthusiasts who are not rugged backpackers.

The strong environmental emphasis, notes Mr. Nobis, which should have been present much earlier than now-is "over-reacting" to past carelessness and dangers posed to the wild, untamed areas. Cited as one danger was the recent Forest Service policies to allow forest growth to go rampant and unchecked while new forestation and wildlife is edged out by the vast overgrowth of older, dying trees.

Another hazard cited by Mr. Nobis, is the new concept of letting forest fires burn themselves. He says, this not only does vast destruction, but is harmful to the soil base and creates erosion and loss of watershed.

Timber Management

Careful timber management which takes into account the environment and its future protection is a better answer for preservation than is allowing forest areas to go untamed.

The multiple use concept stressed by Outdoors Unlimited proposes that preservation must be part of the "use" concept, and development merely for development's sake is unreasonable. But needed development should not be held back solely to the benefit of a few, as against the needs of the many.

The timber industry, notes Nobis, is in the main aware of the need to preserve some outdoor areas, and of the need to *carefully harvest timbers so there will be future growth for future generations*.

Nobis takes care to say that he is proud of his membership in the **Sierra Club**, but that many of its members and other environmentalists though well-meaning, do let their environmental concerns go too far. He also stresses that there are many Sierra members who also belong to **Outdoors Unlimited**, or who recognize the need for **multiple use** and consideration of **all** needs.

10 Years Ago In Hoo-Hoo (1964)

Snark John Hickey Gives A Timely Message to a group of 70 Hoo-Hoo's in Eugene, Oregon. John urged his listeners to get behind a program which "must meet and outsell our competition: steel, aluminum and other materials. It's no longer enough to advertise our companies, to just compete with ourselves...Today the greatest threat to our business is from other materials."

Jurisdiction 1 - The Rochester Club #184 turned out in fine style for a meeting & reception for two S-9 Officers at the Party House on January 22nd. Honored guests were **Snark John Hickey** 60300 and **S-9 Horace Bodge** 42328 of Jurisdiction 1. Brother Horace gave a brief dissertation on the meaning of various words of the Hoo-Hoo language. Snark Hickey told of the plans of the coming convention in Toronto and asked for the support of both the Rochester and Buffalo Clubs. Club President, **Frederick E. Meyer** 58954 presided and presented a Past president pin to outgoing President, **Frank DiGenaro** 66960.

Jurisdiction 2 - Chicago Hoo-Hoo Club #29 announces sponsorship of an 8 week *Industry Wide Night School* on Wood and Wood Manufactured Products. Proposed lectures & subject matter to include: "Wood Identification and Fundamental Properties; Construction-Light Frame, Plank and Beam; Modification of Wood Properties through Chemical Impregnation; Sales Aids, Merchandising and Selling Techniques—to name a few...Cost \$20 per student.

Jurisdiction 3 - Winema Hoo-Hoo Club #216 met March 12th in Klamath Falls, Oregon in spite of the bad weather conditions prevailing. Discussion for the evening centered around the proposed field trip being sponsored by the *Society of American Foresters*. It is scheduled for sometime in June and is aimed at *adult education*. The Club decided to make up a Forest Products Display as part of the field trip.

Jurisdiction 5 - The Vancouver Club #48 authorizes expenditures of \$4,000 in 1964 with an endeavor indicated to the Canadian Forestry Association to contribute a further \$2,000 both in 1965 & 1966...The money would be given to the Canadian Forestry Association for capital improvements at the *Evans Lake Camp for Junior Forest Wardens*. Since the inception in 1959, of this fine camp for the youth of the province, the Hoo-Hoo of Vancouver have already contributed some \$14,500.00! or approximately 42% of the \$34,500.00 so far expended on camp developments.

20 Years Ago In Hoo-Hoo (1954)

a wonderful Hoo-Hoo spirit prevailed. The general feeling was that the two clubs should have joint meetings more often.

Another source of opportunity is the "bull" session or discussion forum, where the member who speaks to the point is often rewarded later by "Thanks for bringing that up."

This is at the rank-and-file level. The next step up is committee service, where one becomes a member of a working team. Shoulder-to-shoulder involvement is hard to beat, when it comes to widening one's circle. Also, committees intermesh, which expands the orbit. This is the road to elective office, and all who progress that far collect a multitude of friends.

"I used to count sheep when I couldn't sleep," one long-term member confided. "Now I count the members I know."

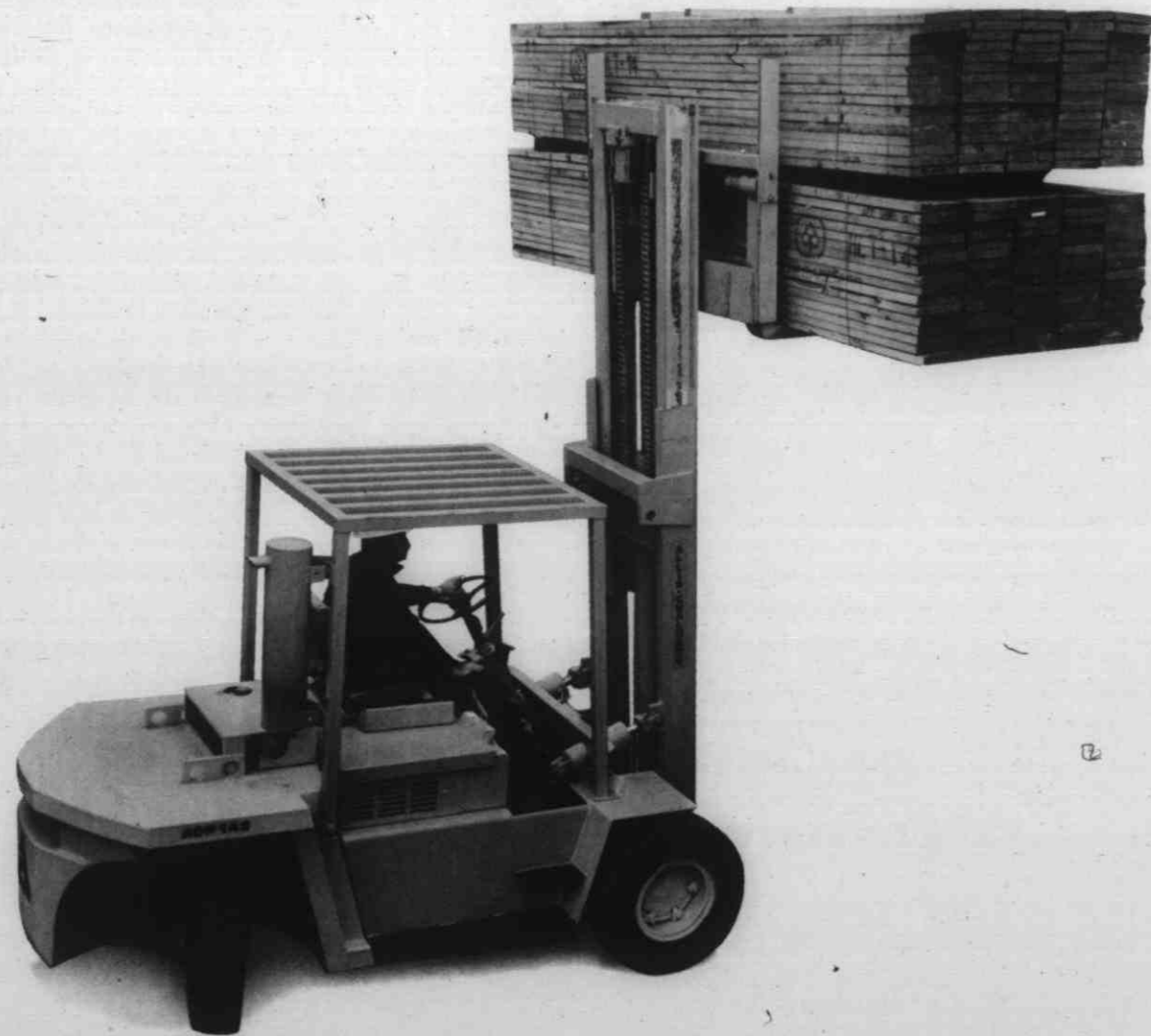

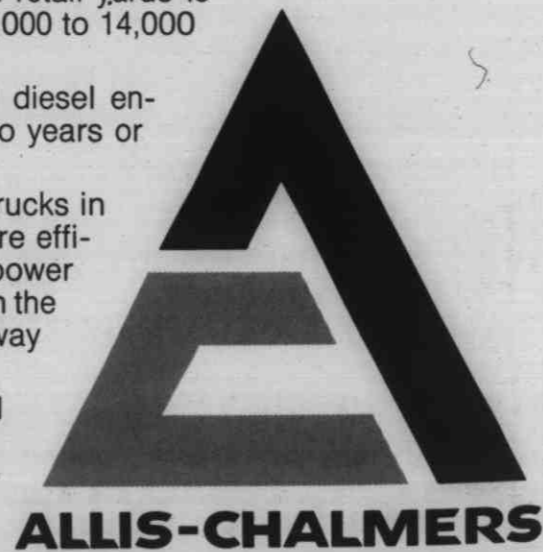
