# Detroit Club 28 Is All Revved Up to Welcome You

#### We're Headed to Motown!

This fall, Hoo-Hoo International is looking forward to returning to Michigan and Motown when Detroit Club 28 (and the amazing Robyn Beckett and her band of merry members) rolls out the red carpet to show us all the good things this iconic American location has to offer!

All the really Cool Cats will gather September 6–10 in neighboring Dearborn, Michigan, at the historic Dearborn Inn. Built in 1931, Henry Ford felt a need for lodging near his airport in Dearborn and commissioned prominent architect Albert Kahn, who built many of Detroit's magnificent landmarks, to design the Inn. This historic property remains popular today. Known for its Georgian elegance and first-class service, the twenty-three acres of meticulously landscaped grounds and gardens make this hotel feel worlds away from the big city. AAA recognized the Dearborn Inn as one of its top 10 U.S. historic hotels.

#### **Convention Highlights**

The Inn is located just two blocks from the Henry Ford Museum, Greenfield Village, and the Rouge Factory. The convention committee has an entire day planned around touring these properties. It will be a great way to learn about the history of the auto industry in America.

Another great day will be when we tour Maickie Distribution on our way to Detroit for the grand ribbon cutting on the Motor City Blight Buster's Hoo-Hoo House! This hands-on Detroit Club project will have special meaning to all of us and getting to meet and spend time with the inspiring MCBB founder, John George, will be a highlight of the convention.

#### Meet John George

The story of John George is an inspiring one. In 1988, this Detroit native was a young family man and part owner in his family's insurance company. He had grown up in the northwest of downtown neighborhood of Old Redford and still called it home. Although the "Big Three" Detroit auto companies still made 95% of the cars sold in America, the population which topped a little over a million, was headed for decline. It was especially bad for outlying neighborhoods like George's which had become, as it has been described, the epicenter of the crack cocaine epidemic destroying lives and property. John George had had enough.

Concerned about the welfare of his family, John took matters into his own hands and to discourage the crashers who turned an abandoned home in his neighborhood into a crack house, John bought sheets of plywood, asked the neighbors to help, and together they boarded it up. The drug dealers moved on.

In a 2002 interview, John George had this to say about that experience, "I've known from a very young age that I was supposed to do something out of the ordinary with my life, but I didn't know what it was until I shut down that crack house." Out of this one simple act he realized he could make a difference, or as he says, "I believe I can change the world, I'm just starting with Detroit!"

First working out of his basement, the growing number of volunteers realized they could begin to take back their community. They improved the look of houses they could save by mowing lawns, pruning shrubs, and applying fresh paint to make a difference. If a house couldn't be saved, they took it down and salvaged everything they could in the process to use on other projects. Outgrowing the basement, the non-profit acquired an abandoned, three-story former Masonic temple for one dollar. Although the building had been empty, except for the rats, cats, and pigeons, for 15 years, John saw the potential and set out to make it a viable headquarters for not only his group, but for another dozen organizations and non-profits as well. With over \$1.4 million in renovations the Motor City Resource Center was born.

#### **About Motor City Blight Busters**

Although these statistics are constantly changing, according to the non-profit organization's website, in its remarkable 25 year history Motor City Blight Busters, in conjunction with its coalition of community partners, proudly claims 120,000 volunteers who have contributed more than 658,000 volunteer hours to paint 684 homes, board up and secure 379 abandoned buildings, renovate 176 houses and build 114 new ones to make suitable housing for 1,160 people.

#### THE HELPING HANDS OF HOO-HOO

In the process, they used 21,000 gallons of paint, 15,500 pounds of nails and 15,470 sheets of plywood. They demolished 113 houses with sledgehammers and people power and undertook 3,850 neighborhood clean-ups, that resulted in 1,550 dumpsters of trash and 70,000 garbage bags.

Over the years, 3,900 neighborhood residents have participated in Angels' Night patrols (designed to prevent criminal acts like arson and violence associated with Devil's Night in Detroit) from the Motor City Blight Busters headquarters. City officials have expanded the program to more than 65,000 volunteers city-wide.

For his unwavering commitment, John George has been honored with the "Points of Light" award by President Clinton, given to people who have done outstanding volunteer work. He was also given a 2012 VW by Oprah Winfrey as part of a program she had to honor exceptional volunteers in America.

#### The Blight Buster Hoo-Hoo Connection

Around 2008, Detroit Club member Matt Miller's church volunteered their services to help on a MCBB project. When Matt went to his next Hoo-Hoo meeting, he told them about the great things Blight Busters was doing in the community. Club President Robyn Beckett was inspired to contacted John George to see how they could help. A friendship was born and Blight Busters became a favorite program for Detroit Club 28. They have donated money, time, materials, and more. John George said, "Hoo-Hoo is a true friend and supporter of what we are trying to do and we are honored." So honored, John George became a Hoo-Hoo!

In the adjacent buildings on the block of the Motor City Resource Center, new businesses have taken root. The Motor City Java House and Café is part of a complex called Artists Village, a joint project involving Blight Busters, artist Chazz Miller and others. Artist Village is an incredible program for artist and youth in the area focusing on working within the community to cultivate art and creative expression. One of the artistic endeavors includes a Saturday night open mike session called Creative Juicez where poetry, jazz, R&B, and more takes place. In the central courtyard, made out of reclaimed bricks from demolished fireplaces, is a barbecue pit and outdoor pizza oven. It is a gathering place for locals.

And, it is here, above the Java House, that the new Hoo-Hoo House is being built. The "new" hardwood floors are also reclaimed from other projects. And, as you've heard, the tile floors in the bathroom and kitchen were laid with the Hoo-Hoo hands of Snark Ron Gattone and S9 Jack Miller. We will see these floors and more when the official dedication of the Hoo-Hoo House takes place during our Convention. John has promised an interesting program filled with the mission of the Motor City Blight Busters. We will also see their new project called Farm City Detroit which is a partnership with Fertile Ground Collective & Replanting Roots. This new urban farm and community resource will span two city blocks that were once home to an eyesore of dilapidated, abandoned, rundown crack houses. That is, before John George got a hold of them. Matter of fact, the structural wood that was once in those homes has been saved to build the new raised beds for the garden.

Come meet this incredible human and see what he is doing. Come see what the helping hands of Hoo-Hoo can do together. See you in Detroit!



The man behind the mission: Australian Ron Gattone is part owner and manager of Crescent Timber & Hardware in the Sydney suburb of Annandale. He came to the industry as a builder and in 1991 joined family members—who were already successful in building material retail—to run Crescent Timber Company.

The company employs about 15 people, up from the seven that were there when he took over, and went from monthly revenues of around \$90,000 to over \$200,000 within six months. He's now ready to bring the same dedication to Hoo-Hoo. "It's a challenging time for Hoo-Hoo and I'm hoping that during my term I can make some long term and fundamental changes that will benefit the organization," Ron said.

We have also had to do a complete update on our computer system, which is still ongoing, but getting close to being complete. Thanks to all for past donations and future support to keep a great organization afloat.

As this being my last report as an International Board member, I would like to thank everyone who has made my journey a memorable one. Every where my travels have taken me, it has brought me new rewarding friendships. A special thanks to Beth Thomas, our Executive Secretary. She makes the Snark's job much easier with her quick responses when info is requested.






