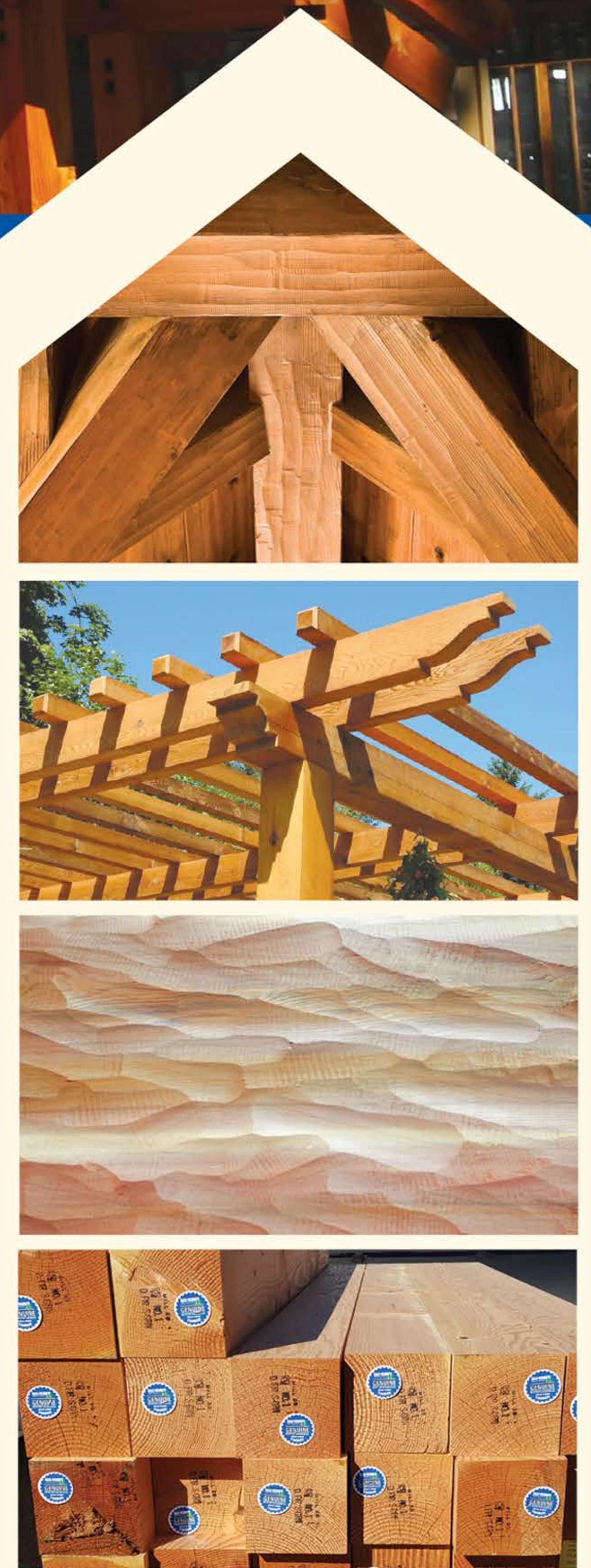

- Kristian Wales presented Tree Farm certificates to Cowles Scout Reservation and Camp Fossean. This made more than 133 Boy Scout properties, including over 113,000 acres of woodlands, which had been certified as tree farms. They joined over 31,000 private landowners with 74 million acres of woodlands, which made up the American Tree Farm System. This program promoted forest conservation.
  - We had a total revenue of \$77,665.30 and expenses of \$71,682.53 for a year-end excess of \$5,982.77 and assets on hand of \$65,875.53 and 7,738 members, the first year in 13 years with an increase in membership.
  - In 1971, the forest products industry in Oregon and Washington accounted for \$3.4 billion into the economy, \$1.3 billion in wages for 147,001 jobs in mills and 1,631,700 persons receiving direct support from the forestry industry, or 44% of the population of Oregon and 22% of the population for Washington. Paper and Pulp vs Lumber were fairly divided as to which was the most valuable product.
  - The cassette tape was a fantastic new invention that made portable music and motivated workers.
- As we reflect back, how has the forestry industry changed in the last 50 years and what can we do to not just grow Hoo-Hoo, but grow our industry?

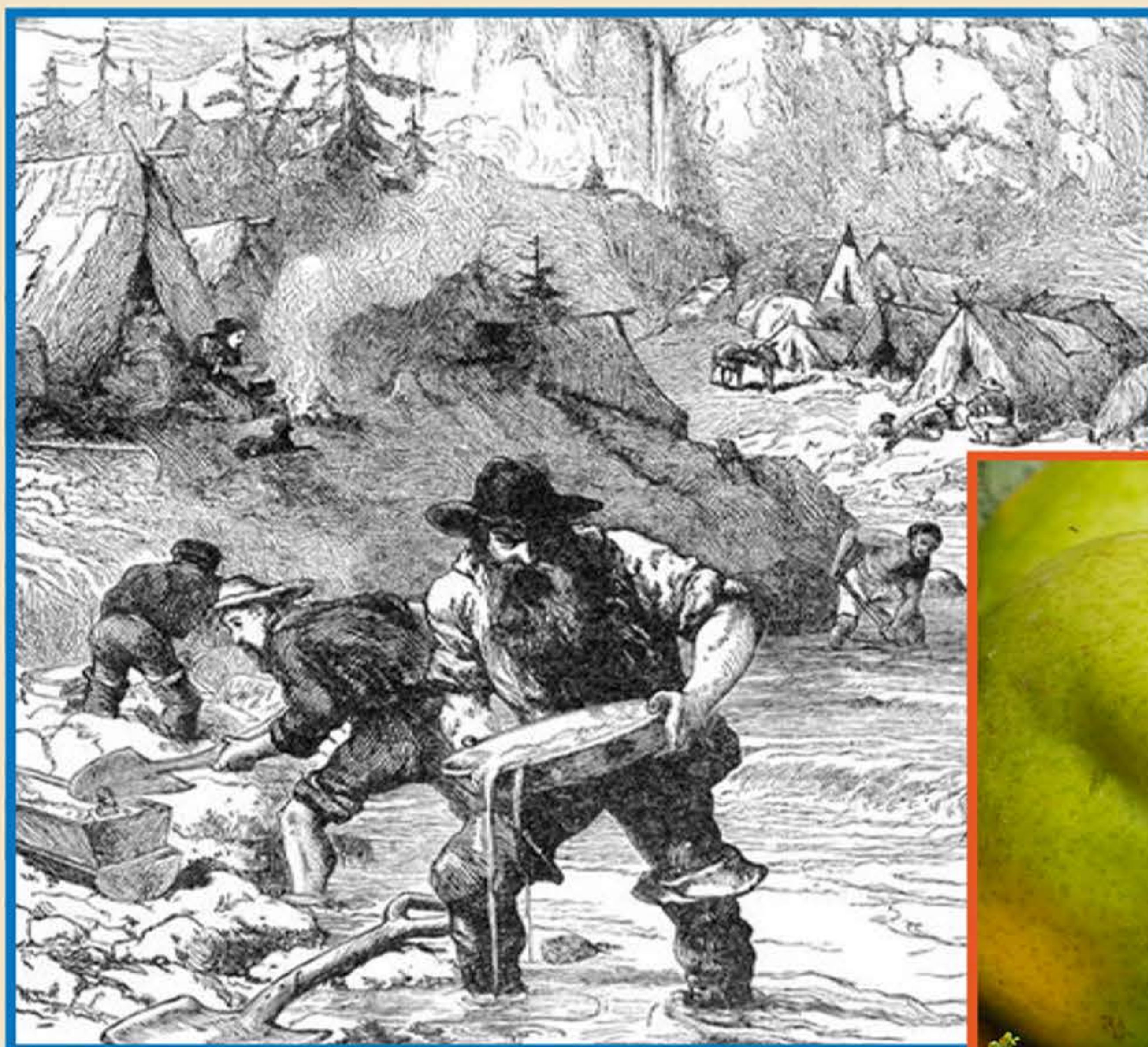

### J2-Detroit Club 28

It is a beautiful Fall here in Michigan. Not only is the weather nice, but Michigan Lumber Yards are enjoying a record year in 2021. The records being broken are due to prices. Softwood / Hardwood / Sheet goods, many prices triple their normal range. Yards experiencing volume equal to 2019 sales are up 65% from 2019. Softwood & OSB prices dropped almost to normal in late Summer early Fall. Softwood is back on the rise to \$800.00 mbf. Hardwood, especially Poplar, is more than double normal pricing. Poplar is 15% higher than Red Oak. Poplar dropped \$20.00 mbf last week, the first drop in many months.

Huge shipping issues in 2021. We had a container of moulding sitting on a rail car in Los Angeles June 10, 2021. We finally received this container October 14, 2021. Speaking of containers, shipping costs are FOUR times what we normally pay to ship a container door to door. Many of these containers have a \$4,000.00 - \$9,000.00 surcharge per container over and above the FOUR time cost.

I was bummed I had missed the Forest Festival and Beth's Retirement Party on October 30, 2021. I was in quarantine due to a positive COVID test, I am fully vaccinated and had no symptoms. There were some of my coworkers who refused to get the vaccine, they caught COVID, so that is why I had gone and got tested. Unfortunately, I passed COVID to our Son, Daughter-in-law, and Grandson, they are fine also!

Our delivery trucks experience the same miles as 2020 but our fuel cost is up 39.7% over 2020. CDL truck drivers (if you can get one) know they are sitting in the catbird seat. Temporary CDL drivers from agencies are impossible to find. Good luck if you need to purchase a new delivery truck 2021. Crazy times.

Detroit #28 will have our famous Christmas party December 6, 2021. We are excited Snark Paul Todd, Steve Allison R106 and Robyn R104 will attend. We wonder if R105 will make an appearance? Detroit #28 (the only active club in JII) has not had any meetings, or outings in 2021, so this Christmas party is sure to put smiles on many faces.
