As you all know, it's time once again to nominate individual clubs for the honor of receiving the distinguished Wood Promotion trophy. If you would like to nominate a club for the award, please mail the letter of nomination to me at the headquarters in Gurdon. I will carry a list of nominees to the covention in September.

Rules Governing Club Trophy

1.) The club may submit evidence covering all wood promotion projects adopted by the club, including National Forest Products Week.

2.) The entrant club will make its presentation to the judges and the convention. Tangible evidence of the project(s) must be submitted by the club delegate, who must be conversant with the project from start to finish as he may be interviewed by the judges. This evidence may consist of newspaper clippings, photos, scrap books, samples, or display material. A slide projector will be available.

3.) Each participating club must submit a written outline of the wood promotion project(s) to contain the following: (a) a description of the project(s); (b) State the goal of the project(s); (c) Tell of the method of operation; (d) Specify the relative proportion of financial and/or manpower support from cooperating organizations; and (e) Statement of

4.) DO NOT SEND CLUB CONTEST MATERIALS TO THE INTERNATIONAL HOO-HOO OFFICE. The Club delegate is



responsible for all contest materials, and for providing the Log & Tally with a complete story for publication. The delegate may ship the materials, addressed to himself, in care of the convention hotel, marked "hold for arrival on September _____, 19___."

5.) Decision of the judges will be

5.) Decision of the judges will be final. A club is eligible to be awarded the trophy in two or more consecutive years. In the absence of an acceptable club presentation, at the discretion of the judges the trophy may be retained in the International Headquarters for one year. In addition to the trophy, certificates will be presented to the clubs placing first, second and third. No judge shall be appointed who is a member of a club making a competitive presentation.

6.) Hoo-Hoo clubs wishing to make a presentation for the trophy are requested to advise the International Office by letter prior to August 20th of each year.

7.) Each of the following facets of the wood promotion project shall be rated by each judge, independently of the others, on a scale of 1 thru 10 for letters G and D and 1 thru 5 for letters A, B, E, & F, 10 being the best.

A-Accomplishment based on size of of club.

B-Involvement of members.

C—Immediate effect on the community.

D-Lasting effect on the community.

E-Written presentation.

F—Oral presentation.

Jurisdiction I

Since I last wrote about our Jurisdiction II, many good things have happened. I also am sorry for a few disappointments, both on jurisdiction and the international level. Good news first.



Our total income from regular members is approximately \$1,000 less than a year ago; however, new members show an increase of \$3,000 compared to last year. Consequently, the total income from membership fees is \$2,000 more than a year ago.

Likewise, income received from other sources, such as advertising in the Log & Tally, interest, etc., is substantially more than last year, which makes the total income picture for the year look quite good.

On the expenses side, some of the expenses have xceeded the budget for the three quarters of the year, while thers have not. Also, due to the generosity of the Cabe Family in paying off the loan at the bank, our expenses were reduced substantially for this year.

All in all, it appears we will have a favorable report to make when the Hoo-Hoo year ends August 31, 1984.





On Tuesday 12th, I'll be visiting the NEWCASTLE Club, and then after a couple of days at work, will visit our HOBART Club on Friday 15th and NORTHEAST VICTORIA on Monday 18th June.

Before finishing this letter, there is an important subject I wish to address to all of the HHI Board and all of the active Rameses. It concerns the 1992 CENTENARY CON-VENTION and the HOO-HOO CENTENARY itself. Some of these thoughts have been developed as a result of discussions with such people as AL MEIER, EDDIE HUNT, KEVIN KELLY and others, so they are not necessarily original. However, I believe it is not too soon for us all to be thinking about the matter, so that we can allow some time for discussion at the Convention and Board Meetings in Washington next September. Here we go: -....

1. The fact that Hoo-Hoo will be 100 years old in 1992 is something on which we should build the Order's plans for action in the years between now and then.

2. I see a need for a special committee to work on the details of putting together a HOO-HOO CENTENARY BOOK. Such a publication would trace the complete history of the Order, re-printing reports of many of our achievements from issues of Log & Tally over the years, leading up to the 1992 Convention in Arkansas. The BOOK would, I'm sure, be virtually a collector's item that would be in demand by Hoo-Hoo members and others for many, many years after 1992. If only 40 per cent of current members wanted a copy at (say) a cost of \$25 or \$30, the income potential is enormous!! I foresee that the BOOK would have a high level of marketability for the following fifty years and probably its value would increase with time. I think it was ED ROACH in Gurdon last January, who talked about advertising potential. To

be an advertiser in such a publication the industry should be willing to make a special effort. I imagine that advertising costs of up to \$2000 or \$3000 (yes, thousand) would be quite realistic targets. I suggest that the committee for this project should be formed at the Board Meeting prior to the Washington Convention, and should include appropriate members who have expertise in publishing, as well as Hoo-Hoo people who are prepared to WORK and Senior people such as Rameses who have access to information concerning our 100-year history.

3. I also need for a second

Committee to start NOW on planning the 1992 Convention, With 19 planned for Honolulu, 1991 for Australia, there will be many members who will make a decision to attend 1992 for the CENTENARY CONVENTION. If ever Hoo-Hoo has had the opportunity to "strut its stuff", 1992 will be the time. As a basis for discussion, I would suggest that the 1992 Convention Committee be chaired each year by the 1st Vice President of HHI, and that for every year between now and then, the SNARK, 1st & 2nd Vice Presidents automatically be members. However, the continuing Committee should comprise people who our current Board believe to be appropriate. If only 20 per cent of International membership makes it to Arkansas in 1992 - and I predict that they will the CENTENARY CONVENTION ORGANIZING COMMITTEE could be planning for an attendance of around TWO THOUSAND delegates

Gentlemen, NOW is the time to start planning.





This was just a small brass band but a few old timers in Angelina County still insist that the Hoo-Hoo Band put Lufkin on the map and gave it national notoriety the equal of which it never has enjoyed since.

The band was apparently at its popularity peak during the first decade of this century. In 1907 the Lufkin News stated editorially that "if there is a citizen of Lufkin who does not appreciate the Hoo-Hoo Band... he should move immediately to Nacogdoches."

That is about as stern a statement as a Lufkinite can make, at least in polite print. There has been rivalry

between Lufkin and Nacogdoches ever since they grubbed the first stump up there, and suggesting that a Lufkin man move to Nacogdoches is about the same as telling him to go to hell. It works the same way at Nacogdoches, where it's popular to pretend, at least, that Lufkin is the tail-end of creation.

That Hoo-Hoo Band was an outgrowth of a national fraternal organization of men in the lumber business, called the Concatenated Order of Hoo-Hoo.
