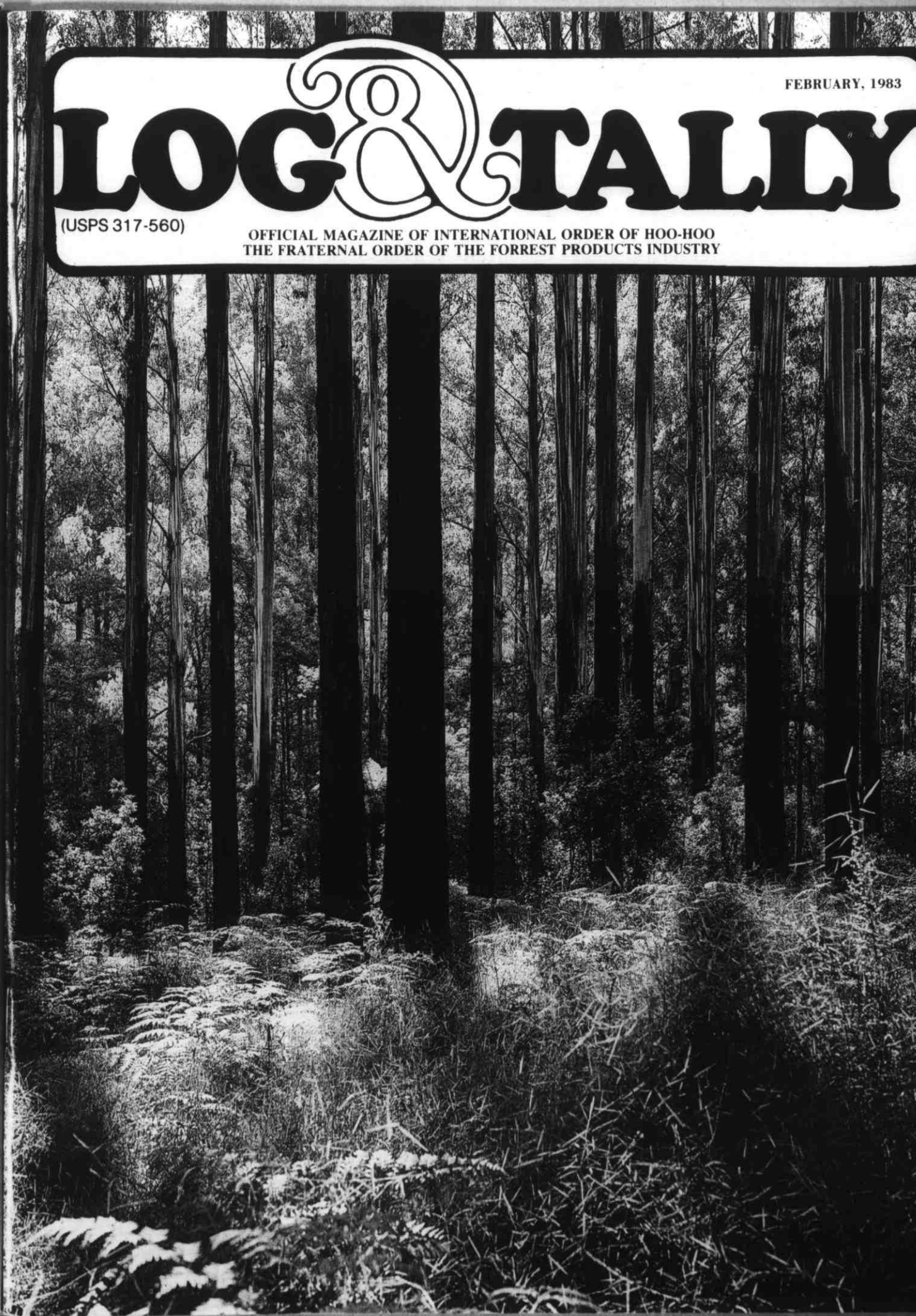

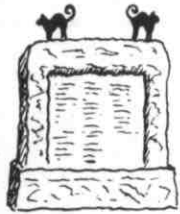

Board's First Meeting In HHI Headquarters

History was made in Gurdon Saturday, October 30, 1982. Real solid, long-term, living Hoo-Hoo history. The picture on this page belongs in the permanent archives of the fraternity and always in the future to tell the story of Hoo-Hoo the events of that day cannot be omitted. A 90-year-cycle came to its pinnacle — from that foundation group of six men in the old Hall Hotel to a full-fledged 30-man Board of Directors, Rameses and guests right here in its own International headquarters.

Snark Kevin Kelly L-75940 came all the way from Australia to wield the giant gavel, call the meeting to order and preside. International Chaplain Jimmy Brunson 63039 of Moscow, Tennessee, offered a prayer for the progress, prosperity and survival of the spirit of the fraternity. Both the International Vice Presidents were present, seven Rameses, the International Secretary/Treasurer and former International Secretary/Treasurer Bill Russell L-50220, the International Executive Secretary and Assistant Betty Wells. All of these with several visiting club officers sat down at a table right here in Headquarters and Museum and spent several hours making plans and projections for the 1982-83 year.

A unique advantage to the International Fraternity is that so large a number of Officers and Members could see and examine the new Headquarters, get some concrete concepts of its workings. They also had two days to ask questions and request explanations — and believe Betty Wells and me — they did just that!

The seed for this gathering of the fraternity in International Headquarters was a terrific idea in the brain of Rameses Jim Jones L-72703 R72. He wrote to us in early September and said he was promoting a mecca of "Friends of the Museum" to Gurdon toward the end of October. "It's a wonderful time to be in Arkansas," he wrote. "We could show off the Headquarters and Museum and possibly make some plans for the future and maybe start thinking about a building fund that is going to be necessary for future expansion. That is the way the idea for a meeting here started and it expanded into an early-in-the-year meeting of the Board of Directors. A good idea that snowballed.

Approximately seventy persons visited i Gurdon some time during those two days. This included Hoo-Hoo Officers and Members, their wives and families. They cavorted with Gurdon citizens in all of the booths and celebrations of the Forest Festival in Gurdon. In the evening they celebrated with a dinner-dance in a nearby motel. Many of them dressed in fantastic costumes and "a wonderful time was had by all."

Special honors went to some Hoo-Hoo leaders during the two-day celebration. Snark Kevin Kelly was given a supreme honor by the community when he was asked to be Grand Marshal of the Forest Festival parade. The Board of Directors meeting was recessed, the Snark was escorted to his open car by Charles Pennington #76642, President of Gurdon Club 120 and away he went

leading the parade through the streets — "Will everyone here kindly step to the rear and let a leader lead the way?"

Another honor to some special Hoo-Hoos came that evening as part of the dinner program. Two special representatives of the Governor Frank White attended the dinner — Miss Diana Thompson and Truman . . . On behalf of the Governor they named three persons — Arkansas Travelers — similar to but a much greater honor, at least in the view of Arkansans, than Kentucky Colonel. Certificates signed by Governor White and bearing all the appropriate ornate scrolling and wording were presented to: Larn Champ L-75820 R70, James Jones L-72703 R72, and Snark Kevin Kelly L-75940.

The visiting ladies were guests of the Hoo-Hoettes of Gurdon Club 120 for a luncheon and style show. The locale was the spacious and attractive Community Room of the Gurdon Municipal Building.

The Board of Directors considered the many questions, possibilities and probabilities connected with Hoo-Hoo with special emphasis on plans for the 1982-83 year. Snark Kevin requested reports from Supreme Nine and other Officers. He plans a very active, eventful and progressive year. As this is being written word comes that he is now in the United States on his second visit here this Hoo-Hoo year.

When the session of the Board of Directors of Hoo-Hoo International adjourned the Directors of the Museum convened in a regular meeting. This group includes all the Directors of the International fraternity plus C. Louis Cabe L-53433 of Gurdon Club #120 and Executive Secretary McClain. The Museum body considered various housekeeping chores of the Museum like adding more lights and extending the collection of pictures of Rameses. Two new items have been made available at International Headquarters to raise funds for the Museum — a color postcard of the building (four for \$1.00) and key rings (59 cents each or two for \$1.00). Proceeds from the sale of these items will go to the Museum Fund. Jim Jones was re-elected Chairman of the Museum Committee.

Hoo-Hoo Board Pledges Support To Gurdon Hospital

Gurdon — now eternally yoked with International Hoo-Hoo as its Headquarters — has a small community hospital called Gurdon Municipal. The community has been working for many months to raise funds to renovate, expand, build a new addition and otherwise improve the facility and has now reached a total of something over \$200,000. They have also obtained approval of an FmHA loan for \$450,000 as part of the project.

This is adequate for the rebuilding project. However, as the community looks down the road they will need furnishings for the twelve new rooms that will be added. Mrs. Anita Cabe, wife of Charles L., Jr. #76640, former President of Club #120, is Chairman of fund-raising. She requested and was granted permission to speak about the project to the Board of Directors.

Following her presentation the Directors voted to launch a free-will offering drive among the International membership and clubs to furnish a private room in the improved facility at a cost of \$2,500. A brass plaque will be placed on the door of the room stating that the room is financed by Hoo-Hoo International. The Cabe family — there are three brothers here who are Hoo-Hoos in addition to Charles L. Jr. — has done a great deal for Hoo-Hoo in moving and financing the Headquarters here.

The Board endorsed financing a room as a fantastic venture in International Hoo-Hoo — Gurdon community relations. Also every member who contributes can feel proud of being part of this assistance in financing the community project. Hoo-Hoo is a vital part of the Gurdon community.

Snark Kelly has sent us a letter enclosing a \$100 check to start the drive to raised \$2,500. It is hoped that individuals and clubs will send contributions of any size to the Executive Secretary. Contributions will be kept in a special fund until the appropriate time that a formal presentation can be made with Hoo-Hoo and City officials participating with the Hospital administration and others. Address: Executive Secretary McClain, P.O. Box 118, Gurdon 71743. Checks should be made to Hoo-Hoo International Gurdon Hospital Fund.

In his letter Snark Kevin Kelly said, in part: "I hope this letter covers what is needed to start the appeal. Perhaps Mrs. Cabe can assist us with further publicity. We will try through the February issue of South Pacific *Log & Tally* to launch the appeal here also." It is truly a wonderful project for the 1982-83 and succeeding years.

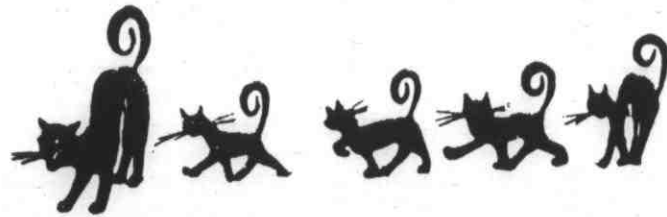

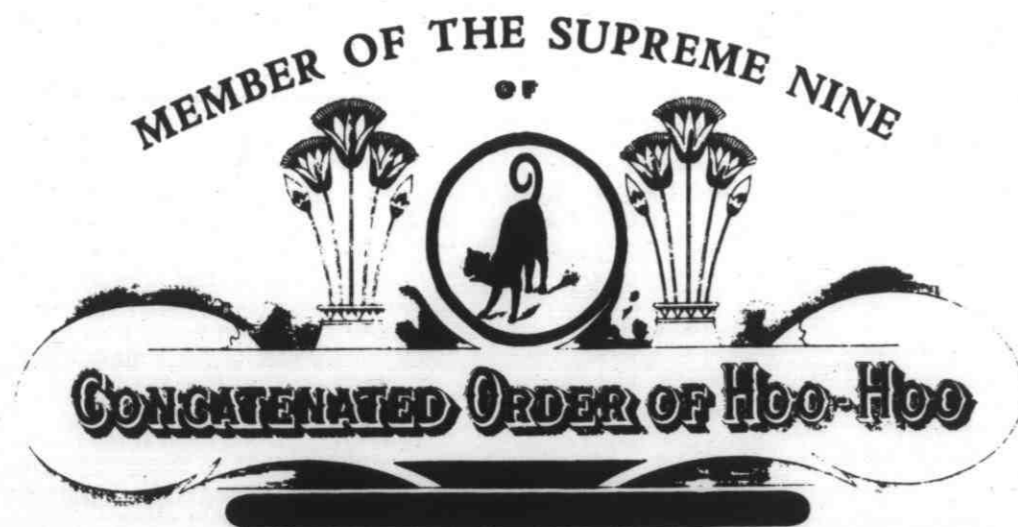


On Nov. 17 I attended the Cowichan Valley Club #229's regular meeting and concat where 5 new members were passed through the gardens.

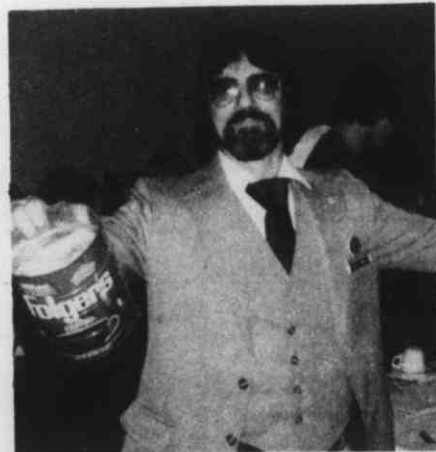

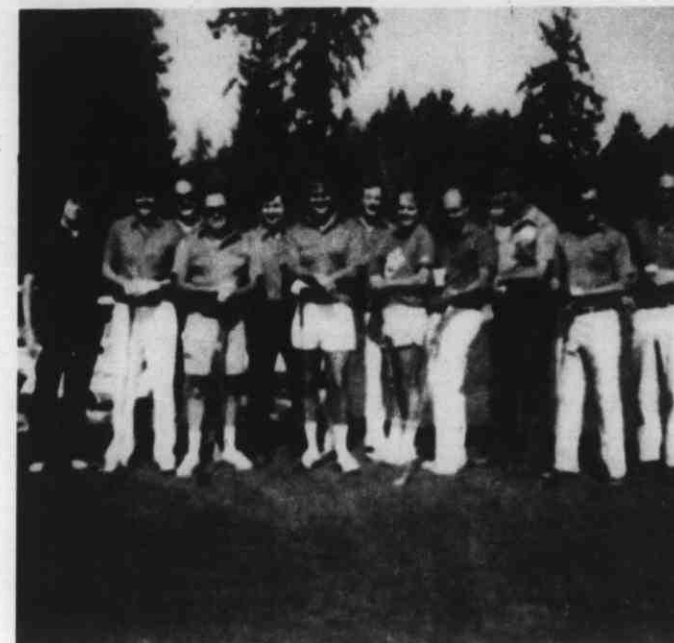
Green Peter Club #226 Golf Tourney A Big Success

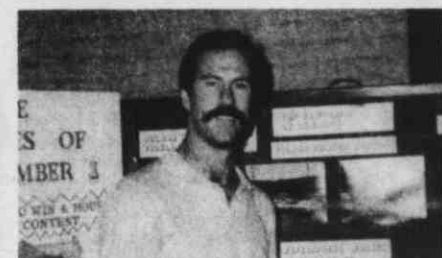

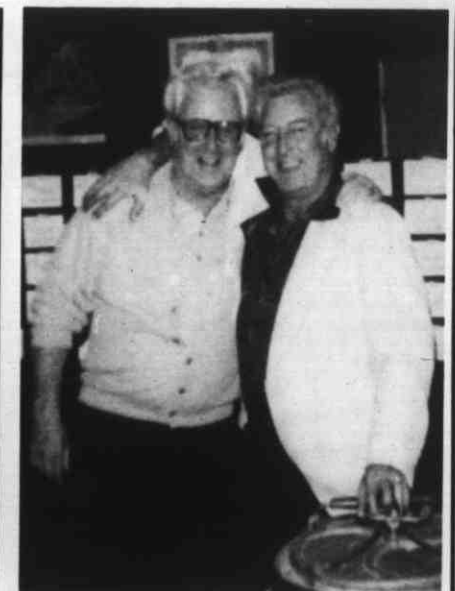
