We were present to argue the bill sponsored by the Detroit Club #28 to equalize the dues structure for all jurisdictions. Issues discussed are listed below:

3. Voting procedure  
A. Change bylaws to 2/3rds approval  
B. Absentee clubs can vote with letter of authorization, submitted to International Office 10 days prior to convention, to S-9 present to cast.
4. Delete word "male" from by laws  
A. To be voted on in Oakland
5. Prorating concat dues  
A. Defeated 13 to 1 (yours truly)
6. Centennial Log & Tally issue.  
(99 pages color 1992)

- A. Individual calling cards will be reproduced at \$200.00 each.
  7. Increase JIV dues \$5.00 to \$7.00  
A. Defeated 11 to 3  
B. Dues to remain same--approved 11 to 3
- Item #7 was two different votes.
- 7A. Yes's First Vice President, Secretary/Treasurer, and yours truly.
  - 7B. No's Secretary/Treasurer, JVIII, and yours truly.

Word of information: JIV (Australia and New Zealand) pay \$6.99 annual dues to the International office while all other Jurisdictions pay \$19.99.

During our argument for dues equalization, S-9 from Australia stated JIV would lose 950 members if their dues were increased. This panicked the Board.

The International has very few to no reserves in dollars. In fact, just before our meeting adjourned at noon on Saturday, Mr. Jones stated the air conditioner was in need of repair before summer (approx. \$4000.00), the office was in need of a microfiche (approx. \$5000.00), and the monument in Gurdon (\$8000.00). I asked where the \$17,000.00 is coming from? Mr. Barber said the general fund. What general fund? Anyway, in the next breath the First Vice President pleaded with the S-9 for JIV to go back to Australia and ask for membership support by accepting a \$2.00 dues increase. Be on the alert for another dues increase for the Americas.

## JURISDICTION III

I attended my first Mid-Year Board Meeting held at HHI Headquarters in Gurdon, Arkansas. I was impressed by the dedication to Hoo-Hoo of those attending. For example, Ernie Wales, Seer of the House of Ancients, and seven Rameses were in attendance along with other visitors from Jurisdictions II and III. Many constructive decisions were made by the Board after due deliberation. All meetings were held at the HHI Headquarters. Both the general office area and the museum are in excellent condition. Beth and Vicki deserve a vote of appreciation for the fine job they are doing. The meetings were constructive

and produced positive results on some controversial issues. On Saturday evening the Cabe family hosted the group to a cocktail party and dinner at their home. The warmth of their hospitality was greatly appreciated.

The Board discussed the proposed bylaw change to remove the word "male". Some of the points in favor are that times have changed; that women are now actively engaged in sales, production, administration, forestry, etc. We have also lost potential male members and corporate support because of the current restrictions in the bylaws. During the last convention, the vote on the proposed change had 70% in favor but lost since our bylaws require a 75% majority to make a bylaw change. I personally feel each S-9 should acquaint his clubs with the benefit in increased membership and corporate support that can be obtained by changing the bylaws. The Board of Directors voted eleven to two in favor of the change.

The Board of Directors reinstated funding for Deputy Supreme Nines effective March 10, 1990. When properly used, this can be an excellent tool for the promotion of Hoo-Hoo.

Joyce Taylor, who produces the Log & Tally for us, made some valid suggestions, such as using black and white pictures for best quality, followed by color and then Polaroid. She suggested improved reporting, feature articles, and club success stories. She summed up her comments by saying, "I can take care of the mechanics, i.e., grammar, spelling, etc., but the magazine is yours, and the type of material you submit will govern the magazines' quality."

Statistically, JIII is doing well. We have concatted 66 new members, which is 47% of our objective at mid year. We still need to place more emphasis on retention and recruitment to reach our goal. Paid up membership now stands at 92%, so we should reach our goal in this area.

Archie Brown from Willamette Valley Club #33 has the JIII mini-conference well in hand, and if early registration is any indication, we should have a good turnout. Remember, Hoo-Hoo members from all jurisdictions are cordially invited to attend. Once again the dates of the Mini are May 18-19-20. You are also invited to come a day early if you would like to participate in the trap shoot.

## HOO-HOO INTERNATIONAL ANTI-TRUST POLICY

The following anti-trust policy as adopted and practiced by Hoo-Hoo International is printed here for purpose of public information.

"Neither Hoo-Hoo International nor any of its jurisdictions, officers, directors, or members will participate in, meet for the purpose of, or even authorize any discussions, agreements, comparisons or other conduct which could be construed as or give rise to an inference of contracting, conspiracy, combination, tying, unfair competition, monopolization, pricing or any other activity which could lead to an inference of restriction of competition price fixing, markups, discrimination, market allocation, or any other conducts prescribed by the Sherman Antitrust Act, the Clayton Act or any other state or federal law relating to competition.

"The purpose of our fraternity is to provide a vehicle for social gatherings, comradery, and most importantly, the promotion and enhancement of the forest products industry both in this country and throughout the world. This policy has been carried on since the inception of this fraternity and is implemented through each member and jurisdiction's participation in community affairs, education, and generally in the promotion of forest products."

# MID-YEAR BOARD MEETING HELD



THE HOO-HOO INTERNATIONAL MID-YEAR BOARD MEETING was held March 9 and 10, 1990, at the Hoo-Hoo Museum in Gurdon, Arkansas.

The Hoo-Hoo International Board of Directors met in Gurdon on March 9th and 10th. During the two-day meeting, the Board voted to support the proposal to delete the word "male" in Article 2, Section I of the bylaws; it approved placing on the agenda for the annual convention in Oakland a proposition for a change in the bylaws to amend the majority vote from 75% to two thirds; and the board reinstated reimbursement for the Deputy Supreme Nines. The board also discussed the possibility of HHI doing their own directory and of mailing questionnaires to members requesting information that would be needed if HHI decided to do their own directory.

Other business discussed and acted on by the Board included the following: acceptance of the resolutions committee's recommendation of no change in the present dues structure for HHI dues, JIV dues, or Life Membership dues; and continuance of the arrangement started in November with Beth Thomas as manager, Vicki Hughes as assistant, and Joyce Taylor as editor and publisher of the Log & Tally.

Another action taken by the board was a change in the voting procedure. The action taken allows the Supreme Nine to represent at the international convention each club in his jurisdiction not in attendance (see item #4 of the voting procedures on page #11). The Board further agreed to include a ballot in the August Log & Tally. The ballot will list the issues to be voted on at the convention so that each member can vote on these issues. Members will return the ballots to their local club secretary.

On Saturday evening, the Hoo-Hoo group was invited to a cocktail party and dinner in the home of Charles and Anita Cabe. The evening was great fun for all who attended and were treated to the Cabe family's warm and gracious hospitality.

### VOTING PROCEDURES FOR OAKLAND 1990 CONVENTION

The following voting procedures were prepared by former Snark of the Universe, Al Meier, for use at the 1986 New Hampshire Convention, later ratified by the Board of Directors and again amended, by approval of the Board of Directors, at the Mid-Term Board Meeting, in March, 1990, for use at the Oakland Hoo-Hoo International Convention in September, 1990.

1. Votes at a convention shall be cast by delegates chosen by each club on the basis of one vote per 50 members of that club, or fraction thereof. (e.g...if a club has 153 members, it is allowed 4 votes...a club having less than 50 members is allowed 1 vote.)

2. There may be more than one delegate per club. Clubs shall have the option to split their votes...the delegates may be allowed to divide the number of votes their club is allowed between themselves.

3. An alternate delegate should be chosen, in case the primary delegate(s) are unable to attend.

4. The Supreme Nine member may vote all the votes of a club who do not have a delegate in attendance at the Convention, provided that club has caucused their members and issued a letter of authorization, signed by the officers of the club, authorizing the Supreme Nine member to vote on their behalf, and as to how they wish the S-9 to vote.

5. The name of each authorized club delegate, and/or letter authorizing the Supreme Nine to vote on the club's behalf, must be submitted to the Supreme Nine, who will then submit these to the HHI Office Manager, at least 10 days prior to the beginning day of the International Convention.

6. If the above requirements are not met, the votes involved will be invalid.

7. The number of votes per club shall be determined by the HHI Office Manager's report, as of July 31, 1990.

8. Members at Large shall be represented by the Supreme Nine of their respective Jurisdiction, on the basis of one vote per 50, or part thereof.

9. Clubs eligible to vote, must have held meetings regularly during the 1989-1990 year.

10. Each Supreme Nine shall hold a jurisdictional caucus at which time club delegates shall cast their votes. The Supreme Nine member shall then present his jurisdiction's final vote to the convention floor.

11. In an instance where a candidate has no opposition, a voice vote of the delegates may be taken.

12. Candidates and issues will be decided upon by the majority of the delegate votes with the exception of bylaw amendments. At this time amendments to the bylaws require three-fourths of the delegate votes to pass. Amendments must be submitted to the membership at least 60 days prior to the opening date of the international convention.

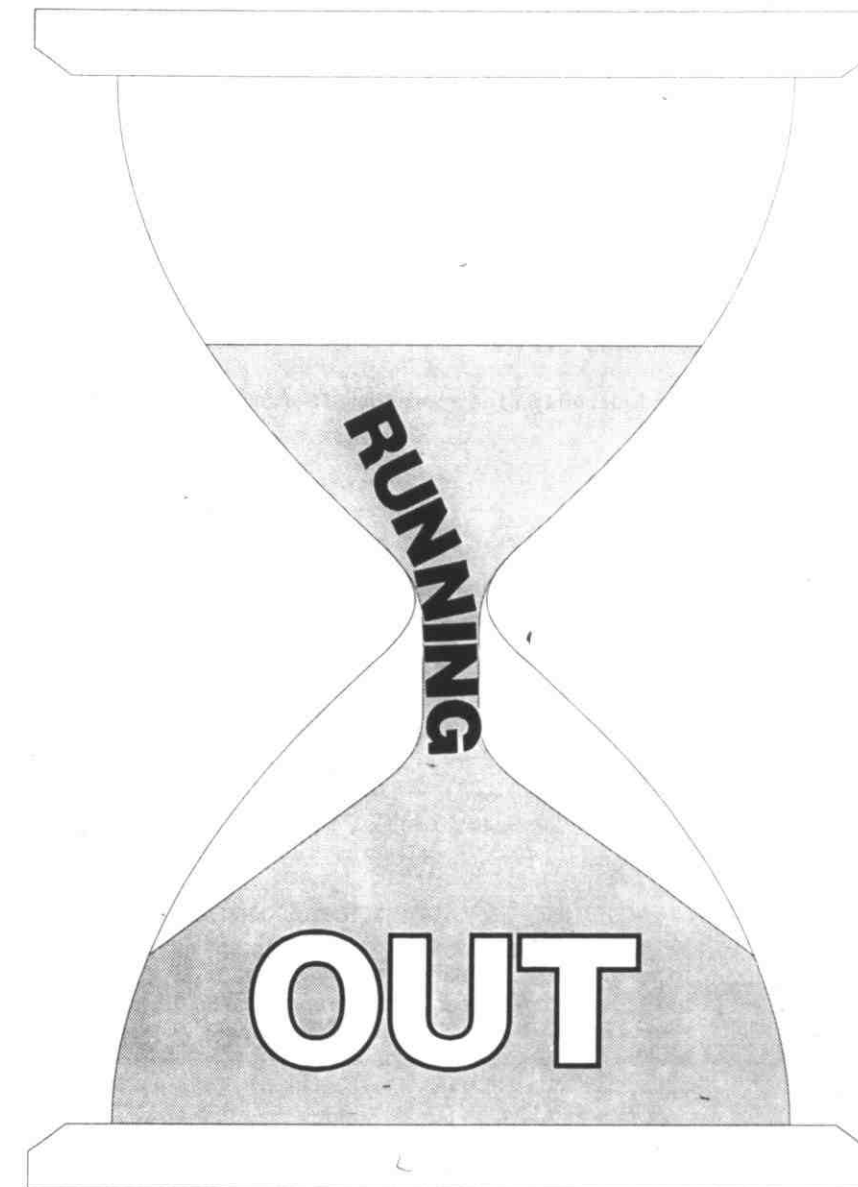

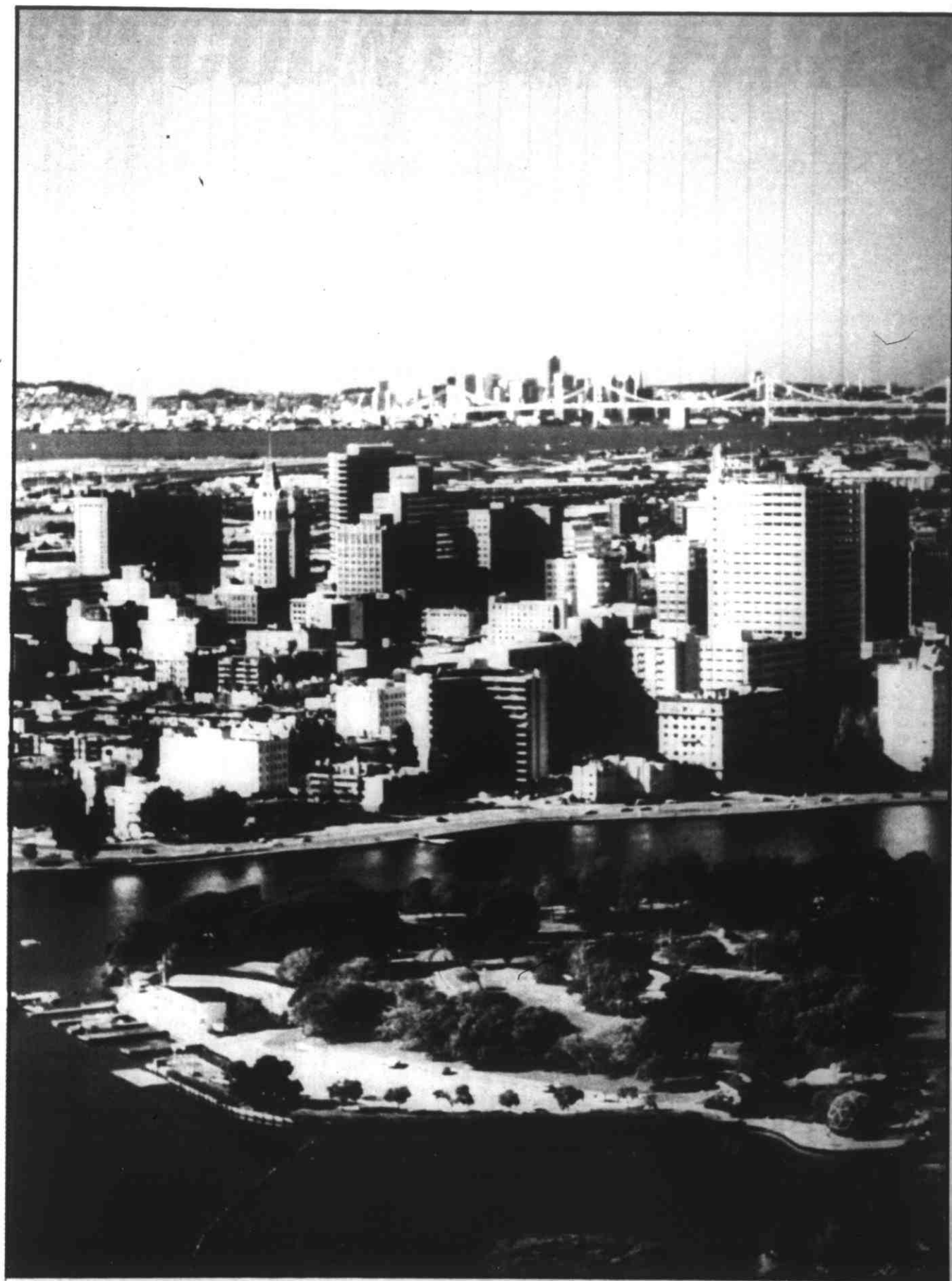
### Many Fetes Planned

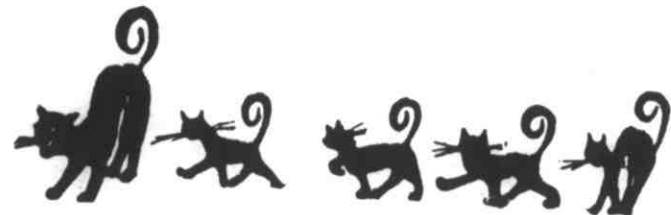

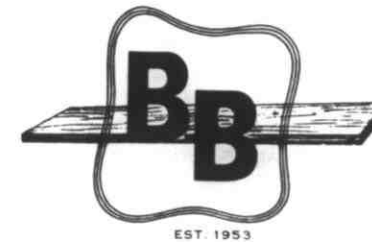
After touring the plant, we all retired to Angelos Italian Restaurant for a well-deserved steak and spaghetti dinner.

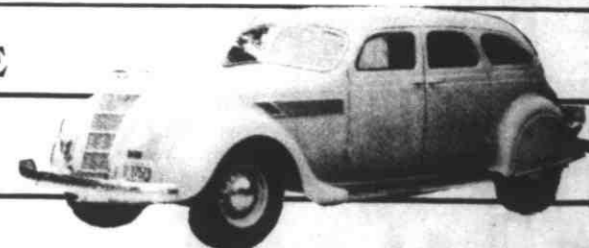

## "LOCK IT UP"

As each day dawns in the western United States, the preservationists seem to find new ways to halt timber harvesting on public lands. Unfortunately, these organizations have an abundance of financial resources to carry on their cause. Since most decisions will be made in Washington, D.C., we need help from all people connected with the lumber industry in all 50 states. Write your congressman and express your views before all lands are "locked up" to prevent agriculture, grazing, and logging. The Supreme Nine in each jurisdiction has video tapes and can obtain factual information for you through such organizations as the Oregon Lands Coalition. The following is a letter I received from Valerie Johnson of the Oregon Lands Coalition.

Dear Dave:

I appreciated you taking a few minutes to familiarize me with the Hoo-Hoo organization and the efforts already undertaken by this fine group in educating the public about the timber supply crisis. The Oregon Lands Coalition is an umbrella group for grass roots groups in Oregon working for the same purpose.

We now have twenty-two member groups, representing 30,000 individuals working on the mission statement: "to increase public awareness of the need for resource protection and resource production. We believe in responsible environmentalism, which is the result of balanced public land management decisions."

As you know, these management decisions are made in Washington, D.C. Our organization is growing rapidly here in Oregon, but our seven congressional votes are not enough to secure reasonable decisions in Congress. We desperately need help from people in other states. Congressmen listen much more closely to their own constituents.

Please encourage your contacts in Hoo-Hoo to become involved in natural resource decisions with their congressmen. Abundant information and materials are available, and we would be happy to help supply materials to your groups. Awareness, education and action is the key to successful public involvement.

Oregon's forest industry is facing drastic curtailments, and other basic industries such as agriculture and livestock are not in much better shape. The "lock-it-up" approach of the preservationists is strangling us all. The only hope for America to continue to feed, shelter and clothe ourselves is for thousands of Americans form coast to coast to demand balanced resource management decisions.

Thank you again for your own efforts in these matters. Please let us know of anything we can provide to help get others involved. We are fighting, not just for our own livelihoods, but for a strong, secure future for America's environment and economy.

### VANCOUVER HOO-HOO CLUB AND THE EVANS LAKE FORESTRY CENTRE

The Vancouver Hoo-Hoo Club #48 has had a long history of supporting a unique community service project. In the late 1950's the club was approached by the British Columbia Forestry Association for assistance in developing what came to be known as the Evans Lake Forestry Centre.

For more than 30 years, the Vancouver Club has provided continuous financial support for this project. Among the many notable early visionaries who helped to initiate the project were Richard Scott, First Canadian Snark, and former club presidents, Wray Clarke and Harvey McDiarmid.

Evans Lake Forestry Centre is now a well established residential childrens camp. The facilities provide comfortable accommodations for 100 persons. It is situated on a small mountain lake surrounded by a 234 hectare (604 acres) Demonstration Forest. The objective of the Centre is to provide a place for learning about the forest environment--its use, protection, value and wise management. It is also a place for recreation, which includes such activities in the summer as swimming and boating and, in the winter, snowshoeing and ice skating.

The Evans Lake Demonstration Forest is well suited for learning about our resources of the woods, waters, wildlife and soils. Seven kilometers of trails, some designed for wheelchairs, wind through an all age forest, which includes mature timber through to new plantations. Harvesting takes place periodically, and children at the Centre have an opportunity to participate in tree planting and tending new plantations.

The Vancouver Hoo-Hoo Club's financial support for the development of the facilities and providing equipment has been vital to the successful operation of the Evans Lake Centre. In the early years, substantial funding was provided for building construction. In more recent years, a fleet of 18 canoes, rowboats and sailing dinghies were donated. During the past few years, the club has undertaken the construction of two new buildings. In 1983, a 840 square foot residence was constructed for the camp custodian/watchman, and in 1987, a 770 square foot accommodation building was constructed. This latter building was dedicated to club member Jack Jacobson and, at that time, Snark of the Universe, whose unflagging support for the Evans Lake project has been so important.

Children are the main users of the Evans Lake Forestry Centre. In 1989, over 5600 attended programs at the Centre. During July and August, a summer camp program is offered for boys and girls 8-15 years old. For the remainder of the year school classes use the facilities for Outdoor School Programs. On weekends, Junior Forest Warden Clubs and other community groups make use of the facilities.

The British Columbia Forestry Association, which operates the Evans Lake Forestry Centre, is a non-profit, moderate organization dedicated to building public understanding and awareness of our forest resources. Jack McLeod, Vancouver Hoo-Hoo Club President and Jan Hermans, Supreme Nine, Jurisdiction V, are both members of the BCFA Board of Directors and help guide this important camp program.

Our club is proud of our involvement and support of the Evans Lake Forestry Centre. When you join us at the 1994 International Convention at Whistler, British Columbia, we will offer you an opportunity for a first-hand look at this place for fun, adventure and knowledge for children.

## FRANK KAUFERT #45143, FORMER DEAN OF FORESTRY COLLEGE

Frank H. Kaufert, 84, of Falcon Heights, dean emeritus of the College of Natural Resources at the University of Minnesota, died recently of heart failure.

Kaufert was director of the School of Forestry from 1947 to 1970, and then served as dean when the school became a college. He retired in 1974.

# WOOD PROMOTION AWARD



**WOOD PROMOTION IS IMPORTANT TO  
HOO-HOO AND THE WOOD  
PRODUCTS INDUSTRY**

**CLUBS ARE ENCOURAGED TO COMPETE FOR  
THE WOOD PROMOTION TROPHY**

The Hoo-Hoo International Wood Promotion trophy is awarded each year to the club which is judged as having best promoted the use of wood, whether locally, nationally or internationally. It is a coveted award that has recently enjoyed a resurgence of interest among Hoo-Hoo clubs who compete for the award at each annual international convention. Perhaps your club could be the next winner of the Wood Promotion Award.

The purpose of a local Hoo-Hoo wood promotion project is to provide a local "grass roots" approach to wood promotion. The local program should supplement and tie in with the wood promotion activities of regional and national programs, because person to person contact and personal influence is a more effective method of selling our side of the wood resource story. Wood promotion projects should be designed to get the broadest local exposure possible to the greatest number of people and should be dramatic enough to have lasting value. Every person in a Hoo-Hoo club's center of influence (city, county and state) should be aware of the role the forest products industry plays in forest maintenance, use and renewal.

## SELECTION OF A WOOD PROMOTION COMMITTEE

The club president is responsible for wood promotion. He should appoint a wood promotion committee with a fireball type self-motivated committee chairman to handle the wood promotion project. The club president or another club officer appointed by the president should maintain close contact with the wood promotion committee to be certain they are getting the job done. Committee members with sales experience, merchandising expertise, and public relations experience are the best types of members for the wood committee since a successful wood promotion project is actually a gigantic sales, merchandising, and public relations effort.

## SPEAKERS, BUREAU OF WOOD PROMOTION

Every Hoo-Hoo Club should, on a continuing basis, have knowledgeable lumbermen available for speaking engagements on wood promotion. Excellent programs on wood promotion are available from the various lumber associations like the American Plywood Association, Southern Forest Products Association, WWPA, California Redwood Association, etc., and from most lumber manufacturers like Georgia Pacific, Weyerhaeuser, etc. These organizations are most happy to supply local lumbermen with these programs for local use. The local chamber of commerce is a good place to advertise your wood promotion program as they usually offer a speakers bureau brochure to their members and are most happy to have "Wood Promotion" included.

An active committee can initiate wood promotion programs for social and business groups like Rotary, Kiwanis, Optimist, Lions, Cosmopolitan Clubs, etc. These wood promotion programs are very popular with these groups.

Public and private schools are quite receptive to wood promotion programs. The students are eager to hear our story, and who could select a better audience to hear this important message than school children.

## LOCAL EXPOSURE

Local public television is a natural for a local wood promotion program. Thirty minute program time for "Forestry" presentation on public television can be purchased at extremely reasonable rates. Imagine the exposure available through the TV media. Proper publicity of your TV wood promotion through free ads can insure a good viewing audience when your show is broadcast.

Radio, newspapers and magazines are also good vehicles for wood promotion activities, and Home Shows

and Trade Shows have in the past proven to be quite effective.

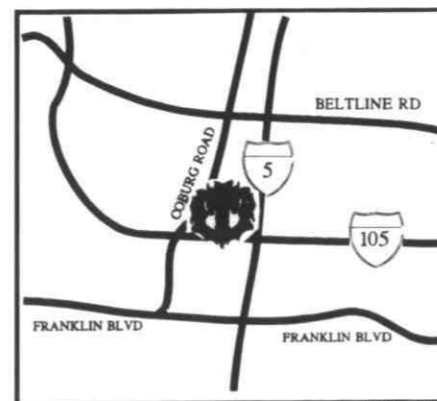

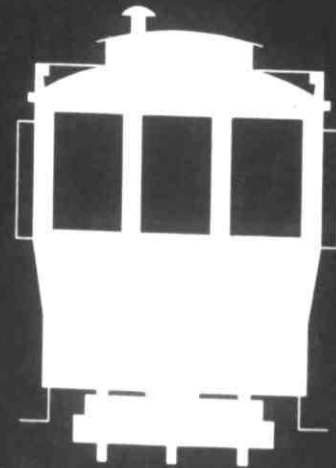
