



# **MEMO**

...from the Snark's desk

## Feds Using Leaky Pail Bailing Out Railroads

Western lumber shippers Friday charged the Carter Administration with trying to "bail out the railroads with a leaky pail, allowing the American public to sink deeper into the sea of inflation."

At the same time, they say the railroads are literally pricing themselves out of the market.

"The government's case simply won't hold water," declared James G. Manning, transportation director for the Western Wood Products Association, following the September 15 cancellation of cheaper "blanket" rates from the 12 western states to the northeastern U.S.

"This will hurt homebuyers already suffering under skyrocketing housing costs," Manning said. "And it is absolutely unnecessary."

The lumber industry has testified at every rate hearing in recent years that the railroads' problems are not the kind that a mere increase in revenue will help. Instead, they say, the railroads should seek to improve weak productivity from within without calling on customers and the public to underwrite solutions to their problems.

Earlier this week the U.S. Department of Transportation had announced support of rate increases to bring railroads a return on investment of as much as 12 percent.

And a series of applications for increases are already being contested by western shippers.

Manning said the abandonment of the blanket rates, which were first initiated in 1935 to help railroads compete with waterborne carriers, will increase the cost of shipping into the Northeast by an average of about 6 percent.

"We believe the blanket rate cancellations are illegal," the lumber shipping expert said.

"When they were instituted 43 years ago by the Interstate Commerce Commission, it was for competitive reasons. Because of that, the ICC must provide an open forum for shippers and the public before making such cancellations

"But this time, rail users were denied the right to their day in court. The rates went up simply because railroads asked for them."

The lumber industry has long contended that the railroad rateraising philosophy actually hurt the rail systems, rather than helping. Shipping statistics tend to support that.

"Ten years ago, two-thirds of all western lumber was shipped out of the West to markets in the East, Midwest and South," Manning reported. "Today less than one-third of western shipments leave the West."

While some of this can be traced to the growth of other lumber producing areas as well, western lumbermen submit as additional evidence the mushrooming use of trucks for both long and short hauling of their products.

"In 1968, railroads were carrying about 75 percent of all shipments of western lumber," Manning said. "That has dropped now to only about 50 percent."

#7.—Solicit more input from members for the good of our order. I find many members have ideas for bettering Hoo-Hoo, but for some reason or other, hesitate to speak up. We might even consider a contest among the various Jurisdictions as to who they feel should receive this honorary membership. I would appreciate hearing from members as to how they feel about this.

I'm looking forward to visiting as many clubs as possible during my term as Snark and welcome your invitation. The most helpful tool available to the Snark for use in his travels is an up-to-date club officer roster. This comes from International provided each club has sent it in. However, Cliff needs these NOW so they can be published in the February issue of the Log & Tally. (The form for reporting this is found on page OA-2 in your club operations manual.)

Rameses Champ covered a lot of territory last year and further nurtured the growth of a positive attitude in our order. The membership committee feels that by continuing this positive attitude, membership can be increased at least 10 percent in 1978 and '79. With everyone's help and the implementation of the above nine points, this can be achieved. Will you do your part to help others share in the friendship, confidence, enlightenment and service found in our order? If you do, we can reach this 10 percent increase in membership.







He told me that by the time the Fair was over, 3,000,000 people would have gone through it. It is highly educational and demonstrates the greatness of our forests and the forest industry.

The best part of our Hoo-Hoo booth was a miniature sawmill made to the scale of 1" to 1-foot. The Hutchins brothers, who operate a sawmill in Weippe, Idaho made this scale model mill, which actually cut up very small logs and made "lumber."

It had a log pond, bull chain, transfer chain to the mill, headrig and carriage, edger, trim saw and green chain. The Hutchins came





# Report from Juris. IV

In Australia we have three National Award which all clubs participate for. This year will see the emergence of a further award, "The Hoo-Hoo National Forest Products Awards" and this should put the name Hoo-Hoo into a large number of homes as a family word.

Our conventions have been planned in the following order. In 1979 we are currently planning to hold our convention in conjunction with your own at Honolulu. This is still to be confirmed at our next convention on September 28th this year. If this plan goes ahead, we will arrive a day or so ahead of your meeting and hold our sessions and then join yours, or we may hold ours immediately after yours. This decision is still to be made. It now appears that we could have between 100 and 150 in attendance at the Honolulu convention.

In 1980 we have allocated Hobart, Tasmania that convention.

In 1981 our convention will be held in Brisbane.

In 1982 we are currently planning to hold the International convention and I offer the personal invitation of all members in Australia to your members in U.S.A. and Canada to attend. You will not be disappointed, I assure you. All Australian clubs will be working to make this one of the greatest conventions ever, and every club will have a member on that committee.

In 1983 we will go to the other side of our continent to Perth, Western Australia.
