# CLOISTER

The Osirian Cloister, long rooted in the deep mysteries of our Order, was at one time the personification of the highest ideals of Hoo-Hoo, and the new Osirian Cloister which is active today has the same high ideals. In the early days of our fraternity, the Osirian Cloister consisted of men who had proven by their acts of loyalty and service to Hoo-Hoo that they should be exalted to a higher degree of recognition. Today, in 1988, the men who conto lauch a campaign to reactivate the group. stitute the "new" Cloister are equally deserving of this honor as their predecessors of old.

The Osirian Cloister was reactivated in 1986 thanks to several an organized body which could enlist the expertise of men who had served Hoo-Hoo in different capacities. A roster of this Order would include the names of Rameses, Vicegerent Snarks and past Supreme Nine members, but only those who had worked diligently for the benefit of the Concatenated Order of Hoo-

The man who was the primary force behind the reactivation of the Cloister was Gordon Graham L-70604 of Detroit, Michigan. Serving as Supreme Nine for J-II, Brother Graham developed an interest in the history and purpose of the Cloister, and after consulting several Rameses who agreed that the new Cloister could be an attribute to Hoo-Hoo International the decision was made

Within a short time the Cloister was reactivated, and the members voted to adopt, among other things, a project aimed at raising money for the Hoo-Hoo Centennial Celebration. The international officers and Rameses who recognized the need for Cloister devised a 50/50 raffle draw whereby tickets were sold for the raffle, and buyers took the chance that they would be the lucky winner who would win half the total monies collected. To date, the raffle has produced over \$10,000 for the Centennial Fund.

#### The History

To understand the existance of the Osirian Cloister, we must go back to the genesis of Hoo-Hoo and look into its structure as it was in the early days of our order.

There is evidence that the Cloister was active as early as 1893 — one year after our fraternity came into existance. This leads us to believe it was an integral part of Hoo-Hoo from the

As a further confirmation of this, the "Tablets of the Law" (By-laws) which governed the Cloister in those early days, refers to Section No. 2 of Article V of the Constitution of the Concatenated Order of Hoo-Hoo. It reads in part -

"The Osirian Cloister Shall constitute the Upper Chamber of Hoo-Hoo.'

And in those same Tablets of the Law, Article II, Section reads -

"The name of the Upper Chamber of Hoo-Hoo is The Osirian Cloister and the dwellers within the Sacred Retreat shall be called Osirians'

This is clear proof that the Osirian Cloister existed from the very beginning of Hoo-Hoo.

In articles appearing in the old "Hoo-Hoo Bulletin" — the forerunner of our present-day Log & Tally magazine, there are references to Hoo-Hoo having two degrees. One was the "Friendship Degree", which was the initiation we all went through when we joined Hoo-Hoo. The other degree was a much more formal function and was called the "Osirian Degree". This was also known as the "Degree of Immortality.

#### Membership

The requirements for membership in the Cloister were -(1) that a man be a member in good standing in Hoo-Hoo for a period not less than two years (2) he had attained the office of Vicegerent Snark and/or (3) he had been a member of the Supreme Nine.

The men who were selected for the Osirian Cloister Degree were chosen with great care and each Osirian was limited to one candidate per year, which he presented to the Cloister for acceptance the day prior to the annual convention.

It was also at this meeting that discussions were held regarding matters pertaining to the good of the order. These matters were then conveyed to the officers and Supreme Nine members

during the business sessions of the convention. It was in this manner that the Cloister made their feelings known to the officers and board

#### Object of the Order

There is no question about the object of the Osirian Cloister, because it is so succinctly written in the Tablets of the Law, Article III, Section 1. It is one brief and pointed statement, which reads as follows -

"The object of the Osirian Cloister is to protect and further the interests of the Concatenated Order of Hoo-Hoo, and members of the Cloister.

#### Purpose

After much research into the Osirian Cloister, we are sure their purpose was threefold - to review the past, take inventory of the present and to lay constructive plans for the future.

#### Conclusion

When you consider the fact that every year some changes are made at the international level, there is little chance for continuity due to the diverse opinions of those in charge.

The men in the Osirian Cloister, since they sit outside the system and do not change with the same degree of frequency can look at all phases of the order with complete objectivity and provide input to strengthen the fraternity.

In our membership, we have a tremendous resource and capacity for service to the entire Hoo-Hoo organization. All we need do now is to tap these resources and capacity.

The Osirian Cloister is the vehicle that fills this objective.



#### INTERNATIONAL SECRETARY TRESASURER'S REPORT By Bernie Barber

There is good news and bad news, as seems to have happened regularly in the last few years.

The bad news is the amount of money received from dues, reinstatements, new members, advertising, interest, sale of buttons and other items was \$157,218.00. The amount budgeted was \$159,930.00 Thus, we are short \$2,712.00 of our anticipated income. We also lost 326 members overall after taking in new members and reinstatements. This loss more than accounted for our loss in anticipated income.

The good news is, the amount of money spent during the year 1987-88 was \$147,776.00 compared to the budgeted amount of \$157,791.00. This was \$10,014.00 less than the amount budgeted for the year. This was due primarily to the fact that some officers, directors and deputy supreme nines did not request reimbursements for their travel expenses. The income in excess of expenses was \$9,441.00 for the year 1987-88. Total assets were \$156,159.00 and liabilities were \$30,900.00, leaving a members' equity of \$125,258.00

#### Perth Hoo-Hoo Club 240 Wins 1988 Wood Promotion Award


The 1988 Wood Promotion contest at the 96th Annual Hoo-Hoo convention in Orlando, Florida attracted three outstanding entries, but the Perth Hoo-Hoo Club No. 240 of Western Australia was chosen the winner. Other entries were the Detroit Club No. 28, and a joint entry by the Melbourne Hoo-Hoo Club No. 217 and the Vancouver Hoo-Hoo Club No. 48. All three entries were excellent, and the men who made the contest presentations to the convention did a first class job.

An outline of the presentations is provided below:

Perth 240 — John Kelderman presented a video showing how the Perth Club developed the Creative Youth Awards contest for handicapped youth in Perth. Students built woodwork items for competition in four categories: (A) Open section, which allowed no assistance, (B) Individual Assembly, which allowed for minimum assistance, (C) Teacher Assistance, which allowed for up to 50 percent teacher assistance, and (D) Team section, which allowed up to four students to work on one team project. He said that 70 items were displayed in the education department and all students received certificates on awards night which attracted 400-450 attendees. The club has conducted the project since 1985.

Detroit 28 - Gordon Graham presented a video regarding the club's program for handicapped youth entitled - "A Step Beyond." The program was so named because this project was a "Step beyond" other wood promotion projects conducted by the club. This program was coordinated by club president Dennis Karas who contacted the Lutz School, which provides work experience for handicapped youngsters. The club donated several power tools and materials to the class, and invited the students to display the items they had made for public viewing. Students were presented with a certificate at the completion of the course, which was made available at the request of the club to introduce the students to woodworking. The items produced by the students were primarily craft items. Following the completion of the video, Mr. Graham presented the Hoo-Hoo Museum with a wooden goose magazine rack produced by the students at the Lutz School.

Melbourne 217/Vancouver 48 — Graham Younger of the Melbourne Club reported that the two clubs have implemented an exchange program that allows a representative from each club to travel to the other club's area to study the local timber industry. After a stay in Canada, he said he was travelling through North America and will eventually travel to North Carolina to study American methods of hardwood production. Mike Roy of Vancouver has already completed his tour of Australia on a similar mission. He said the program was designed to allow representatives from each club an opportunity to study the industry on various levels.

- Overwhelming suppport was received from companies and individuals of the local forest products industry to such an extent that the entire project was funded from industry advertisements in the publication.
- 4. This submission does not rely entirely on the "25th Birthday Book" however, as it is considered that the following media achievements are also relevant:
  - (a) The efforts of the Melbourne Club's special Silver Anniversary Book Subcommittee to bring the book and it contents to the attention of the print, radio and television media, as well as to the general public and to all members of Hoo-Hoo both nationally and internationally.

- (b) The production of a special edition of the pamphlet "Hoo-Hoo — An Ideal in Action" for wide and on-going distribution.
- (c) The extensive coverage of the Club's 25th Anniversary celebrations, and of Hoo-Hoo in the July 1988 edition of 'Timber Trader and Building Material News'.
- (d) The special arrangement that Melbourne Hoo-Hoo Club has with 'Timber Trader and Building Material News whereby, in return for supplying that trade journal with Hoo-Hoo and industry news on a regular basis, the journal reserves space in every edition for all local Hoo-Hoo Clubs. In addition, half of all annual subscription fees to 'Timber Trader' is donated to Melbourne Hoo-Hoo Club to assist the Hoo-Hoo movement in this State with its many and varied community service projects on behalf of the timber industry.

four outstanding industry projects, including Project Learning Tree exhibits on international forestry, an information center for interconvention in Seatle, Washington

The other projects which will receive Hoo-Hoo support this year are the World Forestry Institute, Trees for Life, and Penny

In proposing these projects to the Board, Snark Cocks said, "As a non-profit fraternal organization, it behooves us to pay an increasing charitable role in our industry community as a responsible, caring and involved agency, within the industry from which we gain our sustenance." The Board members agreed, and voted to support the above named projects by making a financial contribution and endorsing their purposes.

PROJECT LEARNING TREE, a division of the American Forest Foundation, is an environmental education program designed for teachers and students grades kindergarten through 12. The program uses the forest as a window into the natural world, and its primary function is to educate students in conservation practices and resource use. PLT provides instructional programs for teachers, and is international in application. HHI will become an "Organizational sponsor" and will work with PLT to disseminate information to Hoo-Hoo clubs which want to sponsor the PLT program in their local schools.

THE WORLD FORESTRY INSTITUTE, located in Portland, Oregon, is described as an evolutionary stage in the growth of the World Forestry Center. WFI stresses the importance of sustainable resources and international cooperation, and fills a much needed niche in the arena of global resource management

The 1988-89 Board of Directors adopted a proposal by new by making a meaningful contribution to international policy and Snark of the Universe Phil Cocks to lend its financial support to economic development. WFI will carry out these goals through which captured the imaginations of delegates at the 1987 Hoo-Hoo national forestry, symposia on global resources and economic development, and international forest research activity. The construction budget for WFI is \$2,000,000, and all donations are matched by Louisiana Pacific Corporation.

TREES FOR LIFE is an international project with a goal of planting 100 million fruit trees in developing countries. The project is designed to increase public awareness of environmental destruction and world hunger in developing countries. The cost of planting six fruit trees is \$18.00. Trees for Life is headquartered Wichita, Kansas.

PENNY PINES is a project which was born out of disaster. In 1987, 800,000 acres of California forests burned, ten firefighters lost their lives, and 1.9 billion board feet of timber was destroyed. For \$68.00 per acre, the Forest Service will plant one acre of trees in a California National Forest, and will provide the same protection from fire, insects and other hazards as given other national parks. Of course, this is a localized program, but HHI will strive to encourage all California clubs to participate in Penny Pines on a very active level.

A fifth project which will receive no financial support from HHI, but has received an endorsement is OPERATION PHOENIX. The goals of Operation Phoenix are similar to Penny Pines, being localized in California as a project aimed at resource recovery on lands damaged by fire. The information has been collected by HHI and will be disseminated to California clubs.

# Spacecoast Hoo-Hoo Club 221 Adopts "Hoo-Hoo Park" Project

In June 1987, the officers of Spacecoast Hoo-Hoo Club No. 221 decided to undertake a project to promote Hoo-Hoo. After several meetings with Brevard County commissioners, a parcel of county acquisitioned land was selected and given to the club for the purpose of developing the land into a public park.

At the October 1987 meeting of the Brevard County Board of Commissioners, a brief history of Hoo-Hoo was presented by Commissioner Sue Schmidt. It was then that a pitch was made by Ron Thompson, Cal Hoar and Frank Gray that the club would like to develop the site into a public park area. The board voted favorably on the proposal and the land was then donated to the club. This was the first parcel of land given to a group to develop, which was a first for Hoo-Hoo as well as the county.

Many meetings have taken place between Ron, Cal and Frank and the Department of Parks and Recreation. During these meetings the park has been planned and agreements between Club 221 and the county have been made. During this time the park has become known officially as "Hoo-Hoo Park," and will remain so, far into the future.

The county has hired an organization to do an environmental analysis of the site. They have also hired an architectural firm to draw plans for the park. The county has also agreed to clear the

land, supply fill, build a parking area and provide utilities. The club has agreed to build the park which will be an educational park promoting the use of wood and wood products. The park will consist of approximately 3,500 foot of boardwalk, a nature center, rest areas, picnic tables and identification plates for the variety of trees and plants on the property.

This lively piece of property is approximately 6.5 acres one mile north of the Rockledge city limits and has frontage on U.S. Highway 1 and 315 feet of frontage of the Indian River.







#### WICHITA 173 HOLDS JOINT MEETING WITH C.S.I.

The Wichita Hoo-Hoo Club No. 173 held a joint meeting in September with the Mid-Kansas Chapter of the Construction Specialists Institute (C.S.I.). C.S.I. is the Construction Specifications Institute with headquarters in Arlington, Virginia. There is an affiliate organization in Canada. C.S.I. was established on March 19, 1948...forty years ago. The Mid-Kansas Chapter (Wichita) was chartered on June 10, 1976, twelve years ago, and has about 80 members. There are about 20,000 members in the United States. For administrative purposes, the U.S. is divided into ten Regions. The Wichita Chapter, along with 19 other Chapters from nine states, is in the North Central Region.

Like the Hoo-Hoo organization, membership spans all elements of the construction industry; e.g., Professional Engineers, Architects, General Contractors, Industry Representatiaves, etc. This provides a common meeting ground, a forum, for those engaged in every facet of the industry. Thus, differences tend to be

minimized and similarities are expanded upon and capitalized. The result, of course, is a stronger, more cohesive and ever progressive industry of friendly people.

The primary thrust of C.S.I. is to provide a degree of clarity and uniformity in the writing and interpreting of construction specifications . . . quite simply, getting the facility built with no unnecessary delays, the way the owner wanted it to be built.

This is accomplished through a variety of voluntary educational programs starting with something as basic as a general membership dinner meeting held on the second Monday of the month at Days Inn. There are monthly "Teck Tawk" breakfast meetings where specific subjects (e.g., carpets, earth moving, fire protection sprinklers, etc.) are discussed by a panel of experts with much audience participation. For more in-depth studies of a given subject, seminars are arranged usually through the Marcus School for Continuing Education at the Wichita State University, Regional and National workshops and seminars are offered throughout the year at various places around the country on many subjects. Many of these programs are offered on audio and video cassettes.

The Wichita Chapter annually sponsors a PRODUCT FAIR at Century II. The next one is scheduled for Tuesday, March 21, 1989. These shows provide industry people an opportunity to showcase new products and demonstrate new services being offered to the design professionals, general contractors, building owners and managers, school and government administrators, etc.

The local Chapter also maintains volumes of reference material at the local public libraries. It is developing plans to provide scholarships and other forms of student assistance.

In Short, C.S.I. in general and the Mid-Kansas Chapter in particular are eager, active and viable organizations hard at work today making improvements in the construction process while researching and planning programs for an even better future.




