# Help to Help Rise from the Ashes

**“FIRE!!”**

Never a word you want to hear if you are in the lumber industry. It is even worse when that fire consumes everything you hold dear as many victims of California's recent devastating wildfires now know all too well.

All money collected is redistributed to those in need.

After years of drought, every western state has suffered devastating losses from wildfires. We all saw the evening news in 2017 when uncontrollable flames ripped through communities in northern California affecting so many families and businesses—some directly involved in our lumber products industries.

To help those families the West Coast Lumber & Building Material Association (WCLBMA) started a program called “Lumber Helping Lumber” which gathered donations to offer some immediate relief for our fellow professionals. Sadly, the 2017 program needed to be reprised for victims of the 2018 fires, mostly in the Paradise/Chico area north of Sacramento.

“We've had great support so far from Hoo-Hoo clubs including Sacramento 109, Black Bart 181, and Willamette Valley 33,” said Ken Dunham executive director of WCLBMA and SoCal 107 member. “More money comes in every day and we are continuing to pick up names of industry-related people needing a little help.” Along with Hoo-Hoo clubs and members, other organizations have also sent checks including the Northeastern Retail Lumber Association.

WCLMBA is determined to assist where it can by working with association members and others to determine which of their employees need extra help now.

The program is a short-term pass-through process to get direct financial aid to those with immediate needs—food and clothing, tools, temporary housing, basic necessities of life—anything to take some pressure off in this time of need is the purpose of the program.

The various public and private relief agencies are effective in providing what they do to help people rebuild their lives. Lumber and building materials companies are working on their own to assist their employees, but a little extra is needed for many of those who suffered losses.

“As of mid-January we have received over \$49,000 and have written 39 checks to those in need,” said Ken. “It's all very overwhelming and gratifying to see just how many neat people there are in this industry.”
