Donation: At the 2016 Cairns HHI Convention, the following clubs pledged to make contributions to offset the 2016-2017 HHI Deficit Budget: Portland Hoo-Hoo Club 47; Tacoma/Olympia Hoo-Hoo Club 89; Black Bart Hoo-Hoo Club 181, Vancouver Hoo-Hoo Club 48; Twin Cities Hoo-Hoo Club 12; Detroit Hoo-Hoo Club 28; Seattle Hoo-Hoo Club 34; and Cowichan Valley Hoo-Hoo Club 229. All the clubs have made their donations.

Hoo-Hoo International Historical Event: In October 2016, Rameses 67 David Marteney L65075 was installed as the new Seer of the House of Ancients. Rameses Marteney is Hoo-Hoo International's twelfth (12th) Seer of the House of Ancients. Due to illness, Seer of the House of Ancients Rameses 62 Wade Cory L-72945 resigned earlier in the year.

HHI Website & HHI Membership Program: Web designer and webmaster Supreme Nine JVII Steve Allison visited the international office last month. At that time, he fined tuned the newly developed Hoo-Hoo Membership Software Program and trained Executive Secretary Beth Thomas and her assistant Tracy Hooks in the management and functions of the program. The membership program provides a tremendous number of new features and capabilities for HHI Officers, local club officers, and members of Hoo-Hoo International. The estimated cost of this project was as follows: Project Cost - \$5500 plus the recurring cost of two domain names — each \$30; Site Hosting of \$1000 annually; SSL Certificate cost \$300 a year; and Vimeo Video System cost of \$300 per year. Thus far, HHI has paid Steve A. a total of \$4000 - \$2000 in September 2105, \$2000 in January 2017 and \$1500.00 in August 2017.

HHI 2016-2017 Strategic Plan: The HHI 2016-2017 Strategic Plan has been implemented by Snark Beckett Young. At the Special Gurdon Board meeting, the 2016-2017 the plan was reviewed and fine-tuned.

Star of Hoo-Hoo: At the Hoo-Hoo Museum Board Meeting September 10, 2016, the HHI board passed the following motion: "Star of Hoo-Hoo for here forth from this day forward shall be sold by HHI or JIV only to clubs for purpose of awarding star to worthy recipients at \$499.99". In response to a request from Winema Club Secretary Paul Wunder, action was taken by members of the board at the October 2016 Special Gurdon Board Meeting to let Club 216 purchase one (1) more star at \$199. A list of Stars purchased as of July 31, 2017, is listed as an attachment to this report.

Log & Tally: Advertising Committee Chairman M. Nicholson and members of the committee have been hard at work in getting advertisers for the *Log & Tally*. They have been successful in getting around twenty businesses to sign a 2017 Advertising Commitment Form. Thanks for a job well done!

After many years as L&T Editor, the talented and knowledgeable Stacey Jones retired. The new editor, Stephanie Ornelas, has completed three (3) issues of the *Log & Tally*, Winter 2017, Spring 2017 and Summer 2017. Stacy Jones, thank you for the many hours you spent in assisting Stephane and adding your "touch" to the Winter 2017 issue. On behalf, of all Hoo-Hoo members, I would like to express our gratitude for all the superb Log & *Tally* magazines you created and produced and the many "side jobs" you took over and completed for our great order.

Tracy Hooks - Part-time assistant: To provide continuity in the functioning of the Executive Secretary duties, and as an assistant who is interested in learning and preparing for the Executive Secretary position when it becomes open. Tracy will be working more hours, three (3) days – five hours per day, in order to receive more experience and training. Tracy working more hours, will also give office coverage in case, the Executive Secretary take vacation days, sick days, etc.

Other Matters of Interest During the 2016-2017 year include:

- HHI recently changed its insurance provider to a firm in Seattle, Washington, resulting in a lower cost. The HHI Administration Committee report outlines the details of the coverage and cost.
- The international office continues to inventory and send promotional tools to clubs and members as requested.
- Jurisdiction VII has been reactivated and Steve Allison was appointed JVII S9.

- HHI savings in the amount of \$85,000 was invested with Alpha Capital Management Group in October 2016. The LPL financial report dated July 31, 2017 is in this packet.
- The international office is submitting regular financial and membership report to board members. The budget committee is also receiving at least quarterly financial reports with bank statements.
- Upcoming HHI Bylaws proposed changes have been published in the *Log & Tally* and are ready for presentation to the 2017 Convention delegates.
- For the first time, all board reports packets for the pre-convention board meeting are being sent electronically. Convention reports will be printed and handled to convention attendees at this year's convention. To save printing and mailing cost, it is hoped that the international office will be able to send these electronically next conventions.



The Snark of the Universe, Robyn Beckett, called an electronic meeting together of the Executive Committee on January 20, 2017 to report and discuss the findings of the Administration Committee in regard to Hoo-Hoo International insurance (Property, General Liability, Non-Owned Auto Liability, Crime, Workers Compensation and D&O/EPLI Coverage) quotes.

It was found that Ken Scrimger, Chair of the Administration Committee, and Mac McIntosh, Committee Member, had found a better coverage at a more competitive price. The comparison between the current insurance coverage and the new quoted coverage were reviewed.

Not many organizations can say that they have been around for that long and it gives me great pride, as I'm sure it does you, to be a part of this great fraternal organizations. I would also like to thank Robyn and all of the Supreme 9 for all of their dedication to Hoo-Hoo. You are a great group to work with!

The Marketing Committee members are: myself, Jack Miller, Paul Boehmer, Heather Gattone, John Taylor, Mandi Siwek, Scarlett Beckett, Sandy McKellar, Terry Haddix, and Stephanie Ornelus.

It is exciting to be a part of the Marketing Committee. Marketing can be used in many ways to help to build membership which is the #1 goal. A strong membership base is the key to our success. How we market Hoo-Hoo into the next 125 years will be a huge part of keeping and growing a strong membership base. We need to tell the world who and what we are! There is and needs to be a value in being a member of Hoo-Hoo. This is a key role of the Marketing Committee to promote this.

One of the goals of the marketing committee is to establish a strong network of support with the lumber and forest industries. Our committee must look for ways to best achieve this and then act on them. We have a great web site for HHI that is used to keep our membership informed, to attract new members, and to sell Hoo-Hoo merchandise.

Social media needs to be used as well to promote Hoo-Hoo. Twitter feeds and Facebook are means that can get our message out to current and prospective members.

I mentioned selling Hoo-Hoo merchandise through the web site. This is something that needs to be started soon. Postcards, bumper stickers, and buttons can be sold here. The Marketing Committee will start designing these items and getting quotes on having them made. We can then start selling them on the HHI web site. An e-commerce area of the HHI web site will be used.

There are many small communities in our Jurisdictions that have lumber and forestry-related industries that drive those communities. We could work with government officials in these communities to bring Hoo-Hoo clubs to them. Officials could be asked if they are aware of a few people in the industry who they think would be good candidates to form a club in the community. Of course, we could also research this. Government officials could be told that a Hoo-Hoo club would help create community spirit there. Hoo-Hoo clubs could have special days for their social events that bring the community together. Hoo-Hoo club directors could work with the government officials to do this. If this is done, Hoo-Hoo would be welcomed into many small communities. Towns that are too small to support a club on their own could work with other towns in the geographical area to do the same thing. This could be a huge marketing opportunity for Hoo-Hoo. I know

of many communities in Jurisdiction V, for example, where this has great potential to grow Hoo-Hoo.

Another area that should be explored is contacting post-secondary institutions that offer forestry-related programs. Students and graduates from these programs are a huge potential source for new members into Hoo-Hoo. We could work with faculty members from these programs to promote Hoo-Hoo. Also, if the program has a student advisory board, they could be contacted to see how we can contact prospective members. Posters could also be put up in student information areas to promote Hoo-Hoo.

Students in forestry-related programs are a huge potential area to target in our marketing. Clubs that have these institutions in their area could invite these students to an event to let them see what Hoo-Hoo is all about. Another idea is to have a contest that, for instance, lets them express what they want to achieve in their lives with their degrees or program certificates. The top five submissions would then be invited to the event or meeting to learn about Hoo-Hoo. The club could then build up a database of the other people from their submissions who would also be prospective new members and keep in touch with them.

The other marketing tool that every Hoo-Hoo member has is the ability to talk about Hoo-Hoo to everyone they meet. We have and continue to need to promote this to our members. Our members' experiences and memories of Hoo-Hoo events and meetings are great ways for them to promote Hoo-Hoo by telling people they meet in their daily lives.

125TH ANNIVERSARY BOOK REPORT

The Marketing Committee would like to present a procedural draft to create the 125th Anniverary Booklet for Hoo-Hoo International. We ask that the Board of Directors review, comment and approve this project based on the information presented below at the 125th HHI Convention:

• Create a Committed Committee:

- Committed: Robyn Beckett Young, Brad Techy, Jack Miller, Stephanie Ornelas, Sandy McKellar, Beth Thomas.
- We will also Contact: Stacey Jones, Dave Marteney, Dave Howick and other members of Hoo-Hoo to assist with the design, articles, pictures.
- **Cost:** Obtained from our current publishing company, 526 Design, as a starting point to calculate cost.
 - o Publishing: 28-page plus cover, full-color, heavier paper stock for cover/back is \$5,000.00.
 - o Printing: \$4,624.00.
 - o Goal for just the booklet is \$10,000.

Financing:

- Current Advertising Partners-Work with Mike Nicholson to solicit current advertising partners offering them the opportunity to advertise for the 125th. Offer half-page ad for \$250. Goal: \$2,500. (We should use 25 in the price.)
- Solicit new advertising partners (ask if they would like to also advertise for the upcoming year) getting ideas from the 100th Anniversary Edition. Offer half-page ad for \$250. Goal \$2,500.
 - If we proceed, we have commitments from several companies at this point and will update list verbally at the pre-convention board meeting. 2016 Hoo-Hoo Redwood Grove Report

Addendum #1 by David Jones L-82806



When Kent Bond was Snark of the Universe and visited Winema Hoo-Hoo Club in Klamath Falls, Oregon, he was presented an oil painting similar to the one on the left. Not knowing its history, Snark Bond sent me a picture of his prized new masterpiece and asked if I knew anything about it. I most certainly did, but told him it was a very long story best told over a cold libation and I would be happy to share what I knew over cocktails at the convention in Australia. Unfortunately, as I spend almost no time in cocktail lounges or bars (unlike the Snark), that opportunity was never fulfilled.

You might be wondering how this relates to the Hoo-Hoo Redwood Grove, and like Paul Harvey use to say, "Here's the *rrrrest* of the story."

It would be an understatement to say the original Redwood Grove committee was anything less than an extraordinarily enthusiastic group of Hoo-Hoo members committed to raising funds and procuring a prime plot of majestic trees in the name of Hoo-Hoo. During the selection process of the stand, its purchase, dedication (and for several years after that), annual committee meetings were held in Eureka, California, and included a 50-mile trip up Highway 101 to Prairie Creek State Park (home of the Hoo-Hoo Grove). To get to Prairie Creek from Eureka, you pass through the small town of Orick—current population 357. The tradition was to go to the park and visit the grove in the morning and stop in Orick for lunch on the way back (as Orick was the only "town" close to the state park).

In those days there was only one place to eat in Orick, the Palms Cafe. The Palms was your basic roadside diner with okay food, but NO adult beverages. As you might imagine, this lack of a whistle-wetting option did cause concern. However, the dilemma was quickly resolved as Pat Dorsey's bar, the Lumberjack Tavern, was a one minute (289 feet to be exact) walk down the street. Pat served drinks, but little food so that the committee would have lunch at The Palms, reconvene at the Lumberjack, vice versa, or both.

The Lumberjack was an old-school drinking establishment that catered to locals, farmers, loggers, and truckers. Inside there were dim lights, a long wooden bar with chrome-legged bar stools, a checkerboard floor, jukebox, cigarette machine, and a couple of pool tables. It was a pretty good sized place with enough room for a few couples to dance on Saturday night. On the wood-paneled walls, you would find an assortment of things: a pay phone; photographs featuring loggers, trees, and trucks; the high school football schedule; pool cues; and logging memorabilia.

And there, dead center behind the bar—illuminated by its own light and flanked by mirrors—was the original oil painting of a Black Cat very similar to the one on the previous page.

Pat's Black Cat masterpiece was admired greatly by several committee members, and there were multiple attempts to buy it from him. All offers (some, I am confident were significant) were declined as "the cat is not for sale." Efforts to convince a sale went on for several years with the same result.

During the 1977-78 Hoo-Hoo year when R70 Lauren Champ from Goddard, Kansas, was Snark of the Universe, he, and, his wife, Maxine, met the Redwood Grove Committee in Eureka. They visited Prairie Creek State Park to see the Hoo-Hoo Redwood Grove (in those days it was pretty easy—you could drive there!) and, as usual, the trip included Orick, the Palms, and the Lumberjack, and more attempts to purchase the fine art were made and rebuffed. Possibly in conciliation, Pat allowed the insistent party to hold the painting for photos. That, to my knowledge, was as far off the wall of the Lumberjack as the original Black Cat ever went.

Much like today's Carrolyn Breeden, Maxine Champ happened to be an amateur painter. After returning home, she decided (maybe with Lauren's encouragement) to forge copies of the painting as gifts to those committee members who had voiced

the greatest desire to own the original. I don't recall when these were presented (or for sure how many she painted), but I do know that my dad, R72 Jimmy Jones, and R65 Leonard Putnam each received one. The picture at the top of the first page is the one the Champs gave my dad. And now, Kent Bond R103 has the Leonard Putnam's which the Winema Club somehow obtained from Leonard's estate.

You will agree, I think, that this is more than just an explanation of where the paintings came from or about where the Redwood Grove Committee used to have lunch. It's a small piece of Hoo-Hoo history that illustrates the spirit of Hoo-Hoo and how the principles of this grand old fraternity connect, or should I say, concatenate with so many like-minded people.

This history exemplifies what Hoo-Hoo is all about.

Technology Report 8/22/2017

I am completing a week working here at the office with Beth and Tracy and it has been greatly productive. I have resolved some 20 minor issues with the system that make their jobs easier as well as finishing the photo gallery, support module and officers listing for the website. I will have the calendar completed in the coming few days but have to get on the road to my next destination. As of today here is a list of items yet to complete:

- Adding button to pay past years dues discussing with Beth before I leave today.
- Prevention of adding duplicate username
- Forgot password
- Update username and password
- Navigation issue on some mobile devices
- History Cards action item for Seattle to discuss
- Few small items in the photo Gallery
- Calendar Module
- Log and Tally Searchable Database

I believe this is a complete list of what is remaining and I will push to have most of these resolved by the convention.

While at the office, I was able to complete the following items for improving the working situation for the office.

- Got all of the printers and scanners on the network so that they can print from both computers to any of the devices.
- Worked up proposal to remove many of the anchor weights around the office and moving technology into the 21st century around the office, see section below.
- Consolidated the storage of documents into OneDrive from all kinds of sources so they are online and shareable and to prevent duplication of efforts and lost items.
- Got the office off of Beth's personal Microsoft Office account and onto one that is controlled by HHI

Here is a list of issues to address in seattle so we can move forward.

• Committee information storage - We are proposing that we establish a google account for HHI, in Google Docs, we would like to create folders for each of the HHI committees which will maintain the documents each committee needs for forming their reports and proposals. Basically, HHI would add and remove members access to the folder and each member would be required to have a gmail account(free) to access the documents and then be able to collaborate without the need to bother the office. Here are the benefits:

- No having to ask the office for items as the committee changes
- Online collaboration is simple and members can comment on their schedule and all members can see the comments.
- As members change, you simply add and remove them and they have access to historical information as well as current objectives.
- Free editing and collaboration tools.
- **Printer** In examining the office, they currently have 4 printers for a variety of items and most are between 10 and 15 years old. The printer we are printing membership cards on for the color printing I helped Beth get in 2003. Our current supply costs for all of the printers ink and toner is between \$800 and \$900/year from Beth's research. We can go here, https://www.smallofficesavings.xerox.com/Onboarding/start, and get a brand new \$1099 printer, copier, fax, and scanner that will be on the network for all devices to use and print black or color at double the speed of anything we currently have, for FREE with a FREE service contract. You can see the video of the equipment here, http://a400.g.akamai.net/7/400/5566/v0001/xerox.download.akamai.com/5566/Phaser66 00 WC6605/demo.htm. Now Free sounds way too good, so here's the catch, for the multi function (print, scan, fax, copy) there is a \$13.99/month fee, and we have to pay \$89.00/mo, but the \$75.01 remaining after the fee is deducted goes as a non expiring credit for supplies for the printer. So, for \$1068/yr (or about \$200/yr difference) on a 2 year agreement, we get rid of 4 printers of clutter, upgrade our capabilities, have the capacity to now efficiently make digital many of our historic documents that currently aren't digital, and make the office more efficient.
- Laptops We have not updated the computers in the office in forever. Tracy is using one Beth donated from her daughter's business and Beth's computer was purchased in 2014. These machines are now very slow and lack modern processing capabilities to do their jobs efficiently. We can use the monitors, keyboards and mice for these existing machines and buy 2 new laptops with a budget of \$350 each (probably closer to \$275, but overshoot and under spend) from Wal-Mart. This will give both of them dual screen capabilities and the ability to bring them to conventions and mid year functions so their office will go with them to take notes live when it is fresh in their mind.
- **Phone and Fax** currently we are paying \$35/mo for the fax line and \$50/mo for the main phone line from AT&T. I am proposing that we move to RingCentral for an internet based service that will give the following capabilities:
 - Keep our same numbers
 - Allow forwarding to cell phones if out of office.
 - Call logging for activity usage
 - Free long distance in the US and Canada
 - Conference call capabilities for up to 4 parties.

So here is the cost, to be the most efficient with funds, if we pay annually, the plan for 2 users would be \$599.76/year, a savings of \$420/year with this switch. Now it would require the purchase of 2 new phones which can be reviewed here https://www.ringcentral.com/office/voip-phone.html, we are proposing 1 Polycom

VVX-101 and 1 Yealink W52P Cordless Phone which would be a one time charge of \$248. This would update the office and get our phone system moving in an international direction.

- Internet Beth is checking with Suddenlink, but it looks like they have a better service
 for the same price, she will have update by the end of the week as to availability and
 pricing.
- Email Beth had a task to build functions into the website about sending emails to members. While everybody sees email as a simple task, when you get into bulk sending you need to have someone doing reputation management because as people receive emails in bulk, you will have some who hit spam or abuse on their mail client, this will put you on a blacklist and then none of your emails now will reach an AOL or Yahoo or Gmail or Comcast... depending on where you get blacklisted. If this is a desired goal, there are a variety of sources out there to provide this service similar to a Constant Contact, and they give you reporting to find out who is doing what, but at the end of the day, it is based on volume and a monthly fee. Generally you will pay around \$10/mo as a fee plus somewhere between \$0.04-\$0.50/1000 emails that are sent. That doesn't sound like much but to get to the low end you have to do high volume like one of my other clients who is doing 10,000,000 emails a year and they are only down to \$0.08/1000. As you can see it adds up, so we need to decide if this is something that we want to do and spend the money on.
- Member History Cards/Profile sheets for years, Beth has been printing member histor cards, this is the same information that is now online on the member's profile and Beth has just been printing it and putting it in the file to grow dust. This information on the web is being backed up nightly, so it is located in Newark, DE and Phoenix, AZ in the event of mass fail at Newark. In my opinion, and Beth, there is no reason to waste the paper, ink, and time to print paper to grow dust and a file cabinet to maintain. I am requesting that we do away with this process moving forward. See attachment to this report for an example member card.

I am hoping to have answers to the items above at Seattle so we can get things going and coordinate for the Forest Festival in Gurdon so I can get it all set up then. As you can see, if we do all but the email item, it upgrades the office and over a 2 year term, it is basically a \$0 sum to the national office to get upgraded and clean the clutter along with optimizing the office.

Other critical items are the following:

- Concat issues:
 - We have someone who wants information we are building and is willing to pay
 dues, but is nowhere near an active club and they want immediate access, how
 do we do it, what is the fee, can they buy now on the web?
 - We have someone who wants to be a member of Hoo Hoo but is nowhere near a club, how do we get 2 members signatures? How do they get Concated? Can they join as a member at large? Can this be done through the website?

- Addressing how payment online will work with the local clubs, dues, and card processing fees. Credit card fees will run us about 2.5% as we get it going. There are also capabilities that we could set it up on an ACH system where their dues would just get drafted out of their bank account every 9/9 of the year. We need to get something done and get moving on this so we can get onto bigger and better things.
- What other features moving forward do we want to add to the site for the coming year?
- How are we going to get more buyin?
- To date, we have had 143 people claim their account and we have had 7 login this month. How do we build more traction.

Long and short, the website went live on January 14th and we have been working hard to add to the features. I am much more mobile now and plan on spending more time in Gurdon to help the office out and make the Technology Committee shine and become the spark to ignite the flame in the growth about to come to Hoo Hoo.

Per Kent's request, Ron explained the original idea behind the star. He stated that the Golden Rule was hard to find. He wanted to get elements and put in one form. In 1909 there

had been a similar attempt. He wanted the star to encompass what Hoo-Hoo stands for. He pointed out the 9 ethics in numerical order on arms of star. Golden rule is encircled.

Dave Pratt expressed he is concerned it be a saleable items. Should be awarded to members who have served.

Topic heavily debated per Ron due to its significance. Ron explained there are three ways to award the star

- 1. Awarded to recipient (Star has to be sold by International to the club who then awards it.)
- 2. Individual can buy for \$299.99
- 3. Corporation can buy for \$399.99

Items 2 and 3 create a concern that it is too available.

Larry Viguerie 100356 of Tac/Oly suggested that since it is a priceless emblem and good income for club that two be auctioned off per year.

Ron pointed out two main reasons for star

- 1. Main reason was to award recipient
- 2. Something valuable for Hoo-Hoo to raise revenue

Suggested removing items 2 and 3 and raise price of first.

After lengthy discussion, Ron amended motion as follows:

Star of Hoo-Hoo for here forth from this day forward be sold by HHI or JIV only to clubs for purpose of awarding star to worthy recipients at \$499.99; seconded by Doug Howick.

Further concerns expressed Paul Todd concerned about Cades. Gurdon Club could award this year. It was pointed out that they are members so a non-issue. Dave Pratt of Auckland – expressed that a Life membership is not awarded lightly.

Robyn questioned if more stars could be made. Ron wants to keep uniqueness. The future board will decide if they want to pursue having more made. Nancy Brown wondered if they could be auctioned off to raise money for HHI at \$499.99. Slim Fennel questioned what happens if member passes – does Star go back to club. He suggested amending proposal accordingly to maintain standard as proposed. It was noted that an awarded star is engraved and a purchased star is not. Dave Pratt suggested that museum takes on Stars if member dies.
